<p>1. THE FUTURE EMPLOYMENT OF [REDACTED] NOW SEEMS TO BE WELL ON THE ROAD TO SOLUTION. IN A LETTER DATED 19 DECEMBER 1962 MR. MUCIO F. DELGADO, DIRECTOR FOR EUROPE OF FREE EUROPE ORGANIZATIONS AND PUBLICATIONS, HAS MADE [REDACTED] FIRM OFFER OF EMPLOYMENT WITH THE WEST EUROPEAN OPERATIONS DIVISION AS A PROGRAM OFFICER. [REDACTED] AS BEEN OFFERED A SALARY OF \$11,400 PER YEAR /BASED ON HIS PRESENT KUBARK SALARY AND PRE-SUMABLY INCLUDING A COST OF LIVING PAYMENT TO COMPENSATE FOR THE PX AND COMMISSARY PRIVILEGES WHICH [REDACTED] ENJOYS IN MUNICH PLUS A HOUSING ALLOWANCE OF \$2400 PER YEAR/. MR. DELGADO WILL BE IN MUNICH FOR ABOUT TWO WEEKS BEGINNING 8 JANUARY 1963 AT WHICH TIME THE FINAL CONTRACT WILL BE WORKED OUT. THE EFFECTIVE DATE OF EMPLOYMENT WILL BE EITHER 15 JANUARY OR 1 FEBRUARY 1963 WHICH-EVER IS CONVENIENT TO [REDACTED] WE FAVOR THE EARLIER DATE, AS DOES [REDACTED] BUT WILL DEFER A FINAL DECISION UNTIL ALL ASPECTS OF THE KUBARK TERMINATION CAN BE FULLY CONSIDERED.</p> <p>2. IN OUR DISCUSSIONS WITH [REDACTED] WE HAVE MUTUALLY AGREED THAT HIS KUBARK CONTRACT WILL TERMINATE ON THE DAY HIS NEW EMPLOYMENT BEGINS. WE PRESUME, AND HAVE INSTRUCTED [REDACTED] TO CONFIRM THIS POINT, THAT HIS NEW EMPLOYERS WILL ASSUME FINANCIAL RESPONSIBILITY FOR SHIPPING HIS HOUSEHOLD EFFECTS TO THE UNITED STATES WHEN AND IF APPROPRIATE. HIS NEW EMPLOYERS WILL OF COURSE ARRANGE FOR THE SHIPMENT OF [REDACTED] HOUSEHOLD EFFECTS FROM MUNICH TO HIS NEW POST.</p>

3. WHILE DELGADO ENVISAGES STATIONING [ ] IN PARIS, HE HAS REQUESTED THE LATTER TO COME FIRST TO LONDON FOR A PERIOD OF BRIEFING AND TEMPORARY DUTY DURING WHICH HIS NEW POST WILL BE FINALLY DECIDED, LONDON OR VIENNA ARE ALTERNATE POSSIBILITIES.

4. WE ARE VERY PLEASED AT THIS EMINENTLY SATISFACTORY TURN OF EVENTS AND WOULD LIKE TO GET [ ] SETTLED IN HIS NEW POSITION AS SOON AS POSSIBLE. THERE SEEM TO BE NO INSURMOUNTABLE PROBLEMS INVOLVED IN TERMINATING HIS KUBARK CONTRACT IN THE FIELD WITH THE POSSIBLE EXCEPTION OF THE QUESTION OF REIMBURSEMENT FOR THE EVENTUAL SHIPMENT OF HOUSEHOLD EFFECTS TO THE UNITED STATES AFTER [ ] FINALLY RETIRES, AND WE ARE REASONABLY SURE THAT THIS COST IS NORMALLY BORNE BY FREE EUROPE. [ ] MUNICH QUARTERS ARE LEASED IN HIS NAME AND HE WILL HAVE NO TROUBLE DISPOSING OF THE LEASE IN THE TIGHT HOUSING MARKET. AT THAT TIME HE WILL REIMBURSE KUBARK FOR THE UNUSED PORTION OF THE INITIAL DOWN PAYMENT MADE AT THE TIME THE LEASE WAS SIGNED.

5. HEADQUARTERS WILL BE ADVISED AS SOON AS A DEFINITE DATE FOR THE TERMINATION OF [ ] KUBARK CONTRACT HAS BEEN TERMINATED. FOR PLANNING PURPOSES YOU MAY CONSIDER THAT THIS WILL EITHER BE 15 OR 31 JANUARY. PLEASE ADVISE IF THERE ARE ANY SPECIAL CONSIDERATIONS TO BE TAKEN INTO ACCOUNT IN THE TERMINATION.
