1. Subject's present mailing address: 14 Josephstrasse, FULDA.
2. Address of subject's wife, 20 Saarlauternerstrasse, BREMEN.
3. Subject is working for CIC and can be contacted through the CIC office at MARBURG.
4. He is doing general investigations of sensitive cases for CIC and has worked out a special project on Psychological Warfare based on his own contacts.
5. The special Psychological Warfare project is being done for  organization as represented by . After conclusion of subject's denazification proceedings now being processed through D/ID, and which at present rests with HICOG, subject will probably be absorbed in  organization.
6. Subject is said by CIC to be very definitely pro-Western, anti-Soviet and anti-Communist, as proven by four years of observation on their part.
7. Additional background material:  
Subject's father is a well known wool merchant, living at BREMEN. The father was a Freemason and as such, not highly esteemed during the Nazi time. The fact that the father was not punished in any way was probably a result of his elder son's political influence. Subject's mother is a very cultured old lady with good family background.
8. Subject has one brother, Eric (?) who is at present serving a denazification sentence. Eric's wife did not wait for him to return from PW Camp but obtained a divorce and is now married to an American citizen and is in the US. Her present name and address were not learned.
9. Subject's wife, Erika nee SCHRADER, and his three or four children are presently living at BREMEN.

10. Prior to his being placed in charge of Psychological Warfare, subject acted as chief editor of the "SCHWARZE CORRE", the SS newspaper.
11. Subject was held in England as a PW for considerable length of time after the war. He was sent from ENGLAND to NURNBERG where he was used as a witness only, not being accused of war crimes. As far as is known, he did not work for any western power historical section. This must have been an oversight as the man is a gold mine of information on Psychological Warfare.
12. Subject spent four weeks at an interrogation center in HOECHST operated by the Department of Justice in 1948. At the conclusion of this time he was sent to a PW repatriation center at KUNSTERLAGER, where he was discharged. He was immediately brought to the US Zone of Germany by the CIC where they used him temporarily at METZLAR. In September of 1948 subject was sent to the US by the Department of Justice to be used as a witness in a treason trial, returning in October of that year. Since that time he has been steadily employed by the CIC.
13. Subject has been especially well treated by the CIC, particularly by the officer thereof, and has a kindly feeling of loyalty to them. He is rather dissatisfied and unhappy, in that he feels far greater and more profitable use could be made of his talents and past experiences. From my own conversations with him, I believe that in any program of propaganda directed against communist countries, he could be of great value if properly controlled and exploited.
14. (a) CIC Headquarters especially requests that no attempt be made to contact subject without their knowledge.  
(b) That, subject's denazification proceedings, in particular their assistance in the matter, and that being given by D/ID and HICCG, be not revealed to any other agency.
