SUBJ: CIC Info

On 15 August 1956 the records of the Counter Intelligence Corps, Central Files, Fort Holabird, Maryland, were reviewed in the name of the Subject and revealed the following information:

Reference: Document #D-242953, 66th CIC Detachment

Subject: Guenther \_\_\_\_\_

The file contained a memorandum for the record, dated 24 January 1950, which reflected as follows:

A telephone conversation between Colonel COLEMAN, Commanding Officer of Region X (Bad Wildungen) and Mr. HUGHES of the Technical Specialist Office, concerning \_\_\_\_\_ revealed that he would fall under category three (3) of the Amnesty Law dealing with the Denazification Boards of Germany. Mr. HUGHES advised Colonel COLEMAN to procure a Zugs-Zugs (permission to live) for \_\_\_\_\_ and to establish contact with the German Denazification Board at Kassel to determine their general feelings on cases similar to the Subject's.

The file contained a memorandum for the record, dated 6 January 1950, in the name of Guenther \_\_\_\_\_ which reflected as follows:

On Wednesday, 4 January 1950, Mr. Frank HUGHES, accompanied by Lt. Colonel COLEMAN and Captain WROBLESKI of Region X, went to Heidelberg to confer with Mr. POOLE of DID (sic) in regard to the \_\_\_\_\_ case. Mr. POOLE was shown documents from \_\_\_\_\_ personal file, furnished by the British, which showed that he was released from the British Zone and cleared of crimes as stated in Ordinance 69 (i.e., war crimes). Mr. POOLE was asked if CIC thought they could use \_\_\_\_\_ on right wing coverage. His answer was "yes."

The file contained a memorandum from Legal Advisor's Zonal Office, Herford, B.A.O.R. 15 (sic) dated 2 November 1949 addressed to the 7707 European Command Intelligence Center, A.P.C. 757 - United States Army.

Subject: Operation OLD LACE - Locations  
Guenther \_\_\_\_\_, born 24 October 1910

\_\_\_\_\_ was interned in B.A.O.R. 15 (sic) in 1947, and during this period proceedings were commenced against him under Military Government Ordinance 69 for membership in an organization found
