**SYNOPSIS OF FACTS:**

T-1, of unknown reliability, who is well acquainted with relatives of subject advised that subject and his family came to the United States illegally 2 1/2 years ago. Subject is said to have been the Minister of Interior in Croatia under ANTON PAVELIC in the puppet government of Croatia. This informant states that subject came to the United States from Ireland and that he landed in the port of New York City at which time he posed as a priest. Shortly thereafter he came to the Los Angeles area and hid out under the protection of his brother, JOHN ARTUKOVICH. I. & N.S. records in Los Angeles show that subject, his wife, and 3 children have made application for adjustment of their status as displaced persons. Their present address is said to be 64-B, Surfside Colony, Orange County, California.

**DETAILS:** T-1 of unknown reliability, who is well acquainted with subject's relatives gave the following information in August and October of 1950. Subject entered the United States illegally approximately 2 1/2 years ago at which time he came to the United States posing as a priest. Subject came from Ireland to New York City, New York and thereafter he immediately came to the Los Angeles area, California, took up residence with his brother, JOHN ARTUKOVICH. JOHN ARTUKOVICH lives at 4144 Fulton Avenue, Sherman Oaks, California. T-1 stated that subject entered the United States illegally and that after he came to Los Angeles he was protected and hidden by his brother, JOHN ARTUKOVICH. JOHN ARTUKOVICH is also known as IVON ARTUKOVICH. T-1 further advised that subject and his family are now living at 64-B Surfside Colony, Orange County, California.

MILTON B. BELL, Investigator for the Immigration and Naturalization Service, Los Angeles, advised that their file in this case is now at Santa Ana, California. However, Mr. BELL stated that subject, his wife and three children have applied for adjustment of their status as displaced persons. The five persons who have made application for adjustment of their status as displaced persons are as follows: ANDREJA ARTUKOVICH, also known as ALOIS ANICH, Immigration file 1600-58031, displaced persons application number 7446. His wife is ANNA MARIJA ARTUKOVICH also known as ANA MARIE ANICH, Immigration file 1600-58030, displaced persons application number 7449. The children are as follows: ZORICA DOROTYA ARTUKOVICH, also known as Auria Anich, displaced persons application number 7447. RADOSLAV ANICH ARTUKOVICH, displaced persons application number 7448. VISNJA MARIJA ARTUKOVICH, also known as KATARENA ANICH displaced persons application number 7450. The records of the Immigration and Naturalization Service at Los Angeles show that all the five above listed persons live at 64 B Surfside Colony, Surfside, Orange County, California.

In August of 1949, T-2, of known reliability, advised that subject was second in command in Yugoslavia before TITO came into power and that he came to the United States under cover as a priest to help bring about an independent Croatia. T-2 said that subject has been in Switzerland and was there previous to the time before he came to Los Angeles. He was formerly Minister of Interior in Croatia under AMTIC PAVELIC's puppet government.
