SUBJECT: REDBOX/AROCB - Translation of An Agreement Between the United States Government and GABUSO 3

1. As a manifestation of appreciation of your sacrifice and service, and to indicate our interest in the future welfare of a brave man who undertakes a dangerous mission in behalf of his fatherland and the good of humanity—the United States Government promises to take the following steps in your interest:

a) From the day that your mission begins the United States Government will deposit \$200 per month to an escrow account in your name.

b) Upon the successful completion of your mission you will be entitled to receive an extra \$200 for every six months of service.

c) In the event of your death while in the performance of your services under this agreement, \$3000 will be paid to a beneficiary designated by you in writing. Moreover all monies accrued in your escrow account will be paid to your designated beneficiary at such time.

d) When you have successfully completed your mission, the United States Government will undertake to help you, as much as is reasonably possible, in your personal plans for the future.

e) For the duration of this contract, the United States Government will do all that is reasonably possible to ensure the welfare of your wife and child. Therefore the United States Government promises to pay the sum of 250 DM monthly to your wife. In the event that your wife and child are successful in emigrating to the United States, \$125 monthly will be paid to your wife instead of the 250 DM.

2. Moreover in order that this agreement may be binding you must solemnly agree to honor the following obligations:

a) To keep forever secret this agreement, and all information about the SC, the Americans you have met in training, the content of your training program, the location of all training areas, the equipment used in training and on the mission, and all information which involves the security of your mission, unless released in writing by the United States Government from such obligation.

b) You must also solemnly swear that you will carry out your mission to the best of your ability and to be forever faithful to your comrades and to the great trust placed in you.

3. This agreement will be in effect from the day your mission begins until one month after the successful completion of the mission or until the fact of your death has been reasonably established.
