3. OBVIOUS HERE THAT IF IMMEDIATE CONTACT SISTER AECAMUSO/3 NOT MADE  STORY RE HIS REPRESENTATION GOING TO COLLAPSE BASED ON CONTINUED CORRESPONDENCE BETWEEN WERNER AND LIDACIS.
4. FEAR  WILL BE FORCED TO WITHDRAW BECAUSE OF POSSIBILITY OF REVELATION OF HIS POSITION IF HE DOES NOT GET POWER OF ATTORNEY TO REPRESENT LIDACIS. THIS WE SUGGESTED 19 JUNE, FRAN 7485 (IN 44055). SITUATION OBVIOUSLY DAILY WORSENING.
