REFERENCE(S)

1. Recently AECAMUSO 3's son required immediate hospitalization and an operation due to a serious attack of appendicitis and peritonitis. When Lucy Werner, the child's guardian, brought him to the hospital for admittance, she attempted to have him entered as a third class patient. In Germany the third class patients are welfare cases and their bills are paid for by the German welfare office. However, the third class accomodations were overcrowded and the boy had to be admitted as a second class patient. In addition, Lucy Werner was required to sign a statement to the effect that she would be responsible for the bills incurred in the treatment of the boy. At the time of admittance, Werner was required to pay DM 200.-- as a down payment toward the total hospital bill. Later she was required to pay an additional DM 250.--.
2. Werner immediately got in touch with us to keep us informed of the situation, especially of the financial aspect since she did not have the required money. Due to the critical illness of the boy and the urgency of the situation, Werner was given DM 550.--, approximately \$130.00 in FBPRIME currency.
3. The above situation points up the fact that other unforeseen expenses may arise that are not provided for in Project AECOB, for example, other illnesses, accidents, expenses involved in proc ssing the child for movement to FBPRIME, a possible bonus for the child's guardian, etc. It is assumed that Project AECOB has sufficient funds to enable FOB to pay the above-outlined expenses.
