1. BOY DEPARTS WITH GUARDIAN FOR STATES ON 3 MARCH ON WCC SPONSORED FLIGHT.
 CABLING LIDACIS HIS ARRIVAL TIME. TOO LATE TO MAKE REF A ARRANGEMENTS HAVE HIM ACCOMPANIED BY CASE OFFICER WITHOUT MAJOR UPSET GUARDIAN - WCC - JUGENDAMT PLANS. UPON RECEIPT ISS REPORT AUGSBURG ON 25 FEB, AND BEFORE OUR RECEIPT REFERENCES, AND JUGENDAMT OFFICIALS CAJOLED WCC BUMP ANOTHER PARTY FROM FLIGHT, PERMIT BOY ACCOMPANY GUARDIAN.
