Referring to my July 23 letter, I wish to inform you of the present state of affairs.

A telephon call to the Guardianship Augsburg revealed that the Guardianship up to today did not receive word from the Notary Public to the effect that the Judge was not satisfied with my power-of-attorney. This means that the Judge, considering the special favorable conditions of this case, has accepted the power-of-attorney, submitted by me. Otherwise, the Judge would have informed the Notary Public of the necessity to submit a new power-of-attorney.

The Guardianship told me furthermore that in cases of this kind the Court, before giving its approval, makes enquiries ex officio and the the final approval can be expected after three to four months.

We will therefore have to wait for such a period.
