1. AT 8 JULY MEETING WITH CATOMIC/3, AS DURING SEVERAL MEETINGS PAST SIX MONTHS WITH HIS CASE OFFICER C/3 AGAIN BROUGHT UP TOPIC OF UNILATERAL AIS CONTACT TO SUBJECT (IDEN). SUBJECT AND C/3 HAVE OBVIOUSLY DISCUSSED AT LENGTH SUBJECT'S POSSIBLE UNILATERAL COOPERATION WITH AIS. C/3 ASSURES US THAT SUBJECT WILLING AND EAGER FOR COMPLETE UNILATERAL COOPERATION SINCE BOTH CONVINCED GOVERNMENT AND SECURITY ORGANS OF GFR RAPIDLY LOSING GROUND TO COMMUNIST MENACE (READ ^{SD} SLREN SUCH MENTALITY BEING IN ACCORD WITH NSDAP BACKGROUND BOTH SUBJECT AND C/3. C/3 STATED THAT HE HAD PROMISED TO CALL SUBJECT EVENING 8 ~~JUNE~~ RE OUR INTEREST. WE TOLD C/3 THAT WE WOULD GIVE HIM ANSWER RE POSSIBLE CONTACT AT NEXT MEETING, SCHEDULED 15 JULY AFTER WHICH C/3 COULD PASS ON OUR DECISION.

2. C/3 AND SUBJECT HAVE DISCUSSED SEVERAL SECURE MEETING SITES IN HAMBURG ENVIRONS IN ANTICIPATION OUR FAVORABLE RESPONSE. WHILE SUBJECT AND C/3 HAD CONSIDERED THAT C/3 COULD ACT AS CUT-OUT, THEY DECIDED DIRECT AIS CASE OFFICER CONTACT WOULD BE BEST.

3. IN PRESENT POSITION, SUBJECT ALLEGEDLY HAS ACCESS TO INFORMATION RELATING TO ESTABLISHMENT NEW SOVIET CONSULATE PLUS ACTION CAPABILITY DIRECTLY RELATED TO OUR EFFORTS AGAINST THE SOVIET TARGET. SUBJECT HAS ALSO COMMENTED TO C/3 THAT AIS LIAISON CONTACTS IN HAMBURG (3 AMERICANS) ARE NOT AWARE TRUE SENTIMENTS GERMAN OFFICIALS (SUBJECT'S SUPERIORS) WITH WHOM THEY DEAL.

4. IF HQS AND BASE CONCUR, PROPOSE ^{SEND} ~~YENB~~ WHO ATTENDED 8 JULY MEETING, TDY HAMBURG CA 16 JULY IN ORDER INTERVIEW SUBJECT AND DETERMINE PARAMETERS ^F FUTURE COLLABORATION. WOULD CHECK IN WITH BASE PRIOR TO CONTACT.

5. PLEASE PROVIDE BASE TRACES ONLY. FYI, WE UNDERSTAND HAND CARRIED COPY OF REPORT RE SUBJECT DATED 2 APRIL TO HAMBURG WHILE ON TDY 3 APRIL.

6. IF UNILATERAL CONTACT PROVES VIABLE, WOULD PLAN SEVERAL GROUNDWORK MEETINGS BY AND FOLLOWING SGSWIRL WOULD TURN OVER TO BASE OFFICER FOR FURTHER HANDLING.

7. DIRECTOR: ⁹ ~~NI~~ IDENTIFIABLE STATION TRACES. WILL CABLE BASIC BIO DATA FOR FULL TRACES AFTER INTERVIEW. FOR OBVIOUS SECURITY REASONS WE WILL NOT MAKE EMA CHECKS. FYI, C/3 STATES THAT CAWHISPER CONTACTS HAVE SHOWN ALMOST NO INTEREST OUR
