1. NOON 18 JULY BOLDT WAS ADVISED ALONG LINES REF AND WE APOLOGIZED FULLY, BUT EMPHASIZED WE NEITHER AS INDIVIDUALS NOR AS ORGANIZATION WERE AWARE OF CATOMIC/3 ACTIVITY. BOLDT ASSURED US THAT HE HAD SUSPECTED AS MUCH (A FREE WHEELING UNCONTROLLED AGENT) AND THAT THE MATTER COULD BE CONSIDERED CLOSED.

2. AT BOLDT SUGGESTION,   WILL NEVERTHELESS MEET WESTPHAL ON 20 JULY AS PLANNED EARLIER, BUT EMPHASIS WILL BE TO BRIEF WESTPHAL TO SEND CATOMIC/3 PACKING SHOULD LATTER ATTEMPT RECONTACT. ALTHOUGH WE WILL THUS HAVE A FURTHER READING ON BOLDT'S REACTION ON 20 JULY, WE FEEL THAT HE IS SINCERE AND DOES INDEED CONSIDER THE MATTER CLOSED, AND HOPE THAT HIS SUPERIORS WILL ACCEPT THIS JUDGMENT.

3. WISH TO EMPHASIZE THAT ABOVE ACTION HAS USED UP A SUBSTANTIAL PORTION OF OUR CREDIT WITH HAMBURG POLICE
