MEMORANDUM FOR RECORD

SUBJECT: Conference with CIA (U)

1. (U) Reference, DF, USAFSG, subject: SD 14614 (U), dated 2 February 1967.

2. (C) On 4 April 1967 at 1400 hours. LTC Gord Haber and CPT David Wilson, USAFSG, met with [redacted] and [redacted] CIA at Langley Park to discuss potential utilization of SD 14614. The meeting was established when a USAFSG query (reference 1) through CIA (W) to CIA [redacted] requesting additional available data on SD 14614 resulted in a negative report.

3. (S) LTC Haber provided CIA with additional background on SD 14614 including the past relationship between SD 14614 and a USAFSG Case Officer. LTC Haber reiterated the request contained in reference 1, that CIA [redacted] check its files to provide additional data on SD 14614 and the firm with which he is associated, Standard Industrial SA. LTC Haber also discussed the relationship between SD 14614 and another USAFSG source, F-615. Also mentioned in the discussion was the inquiry made by Senator Javits in July 1966 concerning utilization of SD 14614.

4. (S) [redacted] stated that evidently [redacted] did not have any information on SD 14614, and that CIA (W) did not have a great deal. [redacted] took considerable notes from reference 1 concerning the previous employments of SD 14614 and his known background. [redacted] stated that in July 1965 CIA had received a request through the 66th INTC Group from the Augsburg, Germany police concerning SD 14614 in his true name.

5. (S) [redacted] agreed that he would again query [redacted] and ask for all available information both on SD 14614 and Standard Industrial, SA, based on the additional data provided on subjects background, activities and affiliations since residing in Bolivia. However, CIA representatives stated that in the interest of a more meaningful response to their inquiry the availability of the total data combined in reference would be most desirable and helpful.

6. (S) The conversation then turned to the propriety of using SD 14614. [redacted] stated that in view of SD 14614's past, utilization of the source could only be justified if he could provide extremely valuable and difficult to obtain information. In direct response to a question by LTC Haber, [redacted] stated that probably coordination for a trip by the case officer to contact SD 14614 would require Assistant Deputy Director for Plans approval, and that coordination of a CIOP would require higher coordination.

7. (S) The meeting adjourned at about 1500 hours with [redacted] stating that he would query [redacted] on available information, and [redacted] stated that unless justification for the use of SD 14614 sufficient to offset the apparent risk was determined, we could expect considerable difficulty in coordinating any contact or utilization.
