- FYI: DEPARTMENT HAS RECEIVED REQUEST FROM ANTI-DEFAMATION LEAGUE OF B'NAI B'RITH, AN AMERICAN JEWISH SERVICE ORGANIZATION, THAT US MAKE REPRESENTATIONS TO BOLIVIAN GOVERNMENT TO ASSURE IT ACCEDES TO FRENCH REQUEST FOR EXTRADITION OF KLAUS ALTMANN. ADL REQUEST IS UNDER STUDY BY DEPARTMENT. OUR INTEREST IN ALTMANN CASE STEMS NOT ONLY FROM FACT THAT MRS. KLARSFELD HAS ALLEGED US AUTHORITIES FACILITATED EAR CRIMINAL KLAUS BARBIE'S CHANGE OF IDENTITY BUT ALSO RELATES TO OUR INTEREST IN THE BROADER ASPECTS OF THIS CASE. WE ARE INCLINED TO VIEW THAT IT WOULD BE APPROPRIATE TO INFORM GOB THAT US HAS NO RPT NO INTEREST IN PROTECTING KLAUS BARBIE AKA KLAUS ALTMANN. END FYI
