1. FYI: WE UNDERSTAND THAT STATE WILL BE SENDING GUIDANCE TONIGHT FOR VP BUSH ON THE BARBIE CASE. PRESUME ULTIMATE GUIDANCE WILL BE FOR VP TO COMMENT THAT HE AWARE OF BARBIE RETURN TO FRANCE BUT UNAWARE OF DETAILS AS HE HAS BEEN TRAVELLING ABROAD FOR PAST 10 DAYS. ALSO, EXPECT GUIDANCE WILL RECOMMEND THAT VP AVOID ISSUE TO EXTENT POSSIBLE AS IT HAPPENED OVER THIRTY YEARS AGO.

2. WE DOUBT THAT GUIDANCE WILL INCLUDE ANY STATEMENT FROM PENTAGON.
