LYON JUDGE COMPILING DOSSIER ON BARBIE HAS TOLD AMCONSUL
LYON THAT INVESTIGATION OF BARBIE CASE SHOULD BE COMPLETED
BY THE SUMMER OF 1984 AND THAT BARBIE'S TRIAL COULD BEGAN

JACQUES VERGES, IN WHICH HE ALLEGED THAT RESISTANCE HERO JEAN MOULIN COMMITTED SUICIDE IN JAIL BECAUSE HE WAS DESPONDENT OVER HAVING BEEN BETRAYED BY YELLOW RESISTANTS, HAS SET OFF A CHAIN OF INDIGNANT REACTION. VERGES WAS PROMOTING HIS JUST-PUBLISHED VOLUME ENTITLED "TO FINISH WITH PONTIUS PILATE" IN WHICH HE RECOUNTS HIS CAREER AS A DEFENDER OF A WIDE VARIETY OF LEFTISTS/TERRORISTS AND NATIONAL LIBERATION FIGURES. ONE CHAPTER IN HIS BOOK IS DEVOTED TO THE BARBIE CASE, IN WHICH VERGES CLAIMS THAT RESISTANCE ELEMENTS OPPOSED TO DE GAULLE INFORMED THE NAZIS OF MOULIN'S WHEREABOUTS IN ORDER TO REDUCE GAULLIST INFLUENCE IN THE RESISTANCE. FORMER RESISTANCE CHIEFS HAVE REACTED WITH INDIGNATION THIS WEEK TO VERGES' CHARGES, WITH SEVERAL CITING DIRECT EVIDENCE THAT SUCH A SUICIDE WAS IMPOSSIBLE.

3. LAWYER VERGES EVIDENCE FORGED

VERGES HAS THIS MONTH FILED PAPERS AT THE LYON COURT COMPILING EVIDENCE AGAINST BARBIE STATING THAT ONE OF THE KEY DOCUMENTS IN QUESTION IS A FORGERY. VERGES CLAIMS THAT A PHOTOCOPY OF AN APRIL 1944 TELEX WHICH ORDERS THE DEPORTATION OF JEWISH CHILDREN FROM IZIEU BEARS INCORRECT (FRENCH) SEALS AND THAT BARBIE'S SIGNATURE IS FORGED.

4. BARBIE REMOVAL FROM BOLIVIA TO FRANCE APPEAL CONTINUES

FOLLOWING EXHAUSTION OF ALL APPEALS THROUGH THE COMPETENT FRENCH APPEALS COURTS OVER THE MEANS BY WHICH BARBIE WAS BROUGHT TO FRANCE FROM BOLIVIA, LAWYER VERGES HAS DECIDED TO TAKE THIS COMPLAINT TO THE EUROPEAN HUMAN RIGHTS COMMISSION. VERGES HAS TRIED SINCE JUNE, WITHOUT SUCCESS TO HIS TRANSFER TO FRANCE LAST FEBRUARY.

5. MINISTRY OF JUSTICE STILL CONSIDERING TV COVERAGE OF

TRIAL

A COMMISSION ESTABLISHED BY JUSTICE MINISTER BADINTER TO WEIGH ARGUMENTS PRO AND CON THE TELEVISIONING OF BARBIE'S EVENTUAL TRIAL HAS HELD A DOZEN HEARINGS SINCE FEBRUARY WITHOUT REACHING A DECISION. THE REPORT, ORIGINALLY DUE ON JUNE 30, WILL NOW BE FILED IN PRELIMINARY FORM BY THE END OF THE YEAR. GALBRAITH
