(M) (U) ON 15 MAR, THE HESSE STATE SUPERIOR COURT SENTENCED
WALTER KEXEL AND FOUR OTHER RADICAL RIGHTIST TERRORISTS TO LONG
PRISON TERMS FOR A SERIES OF POLITICALLY MOTIVATED CRIMES. KEXEL AND
THE OTHER NEO-NAZIS ACHIEVED NOTORIETY IN DEC 83 WHEN THEY INSTALLED
EXPLOSIVE DEVICES IN THE POV'S OF U.S. MILITARY PERSONNEL IN THE
FRANKFURT, BUTZBACH, AND DARMSTADT AREAS, WHICH RESULTED IN INJURIES
TO TWO SERVICEMEMBERS. ON SUNDAY, 17 MAR, KEXEL, WHO HAD RECEIVED A
14-YEAR SENTENCE, WAS DISCOVERED DEAD IN HIS CELL AT FRANKFURT
PREUNGESHEIM PENITENTIARY. HE APPARENTLY COMMITTED SUICIDE BY
HANGING HIMSELF WITH HIS BELT.

2. (U) FRANCE.

(A) (U) ON 3 MAR 85, THREE MEMBERS OF THE SECRET ARMY FOR THE LIBERATION OF ARMENIA (ASALA) WERE SENTENCED FOR A TERRORIST ATTACK AGAINST THE TURKISH AIRLINES OFFICE AT THE ORLY INTERNATIONAL FLIGHT TERMINAL OUTSIDE OF PARIS. THE HEAD OF THE OPERATION, VAROUJAN GARBIDIAN, RECEIVED A LIFE SENTENCE, WHILE HIS TWO ACCOMPLICES, SONER NAYIR AND OHANNES SEMERCI, RECEIVED SENTENCES OF 15 AND 10 YEARS, RESPECTIVELY. THE ATTACK OCCURRED ON 15 JUL 83 AND RESULTED IN THE DEATH OF 8 PERSONS AND INJURIES TO 15 OTHERS. AFTER THE SENTENCES HAD BEEN HANDED DOWN, ANONYMOUS TELEPHONE CALLS WERE RECEIVED BY PRESS SERVICES IN FRANCE, ITALY, AND THE UNITED KINGDOM THREATENING REPRISALS AGAINST FRENCH INTERESTS AT HOME AND ABROAD. FIVE OTHER MEMBERS OF THE GROUP WERE TRIED EARLIER AND GIVEN RELATIVELY SHORT SENTENCES COMPARED TO THOSE GIVEN TO THE THREE PRINCIPAL TERRORISTS.

(B) (U) ON 30 MAR 85, A BOMB EXPLODED IN A THEATER IN CENTRAL PARIS INJURING 18 PERSONS, 3 SERIOUSLY. TWO NEO-NAZI GROUPS CLAIMED RESPONSIBILITY FOR THE BOMBING, WHICH TOOK PLACE AT A THEATER IN RIVOLI-BEAUBOURG THEATER WHERE A JEWISH FILM FESTIVAL WAS IN PROGRESS. TWO OBSCURE NEO-NAZI GROUPS, "WORLD UNION OF NATIONAL SOCIALISTS" AND "COLUMN 88 HEIL HITLER" CLAIMED RESPONSIBILITY IN ANONYMOUS TELEPHONE CALLS. ONE OF THE ANONYMOUS CALLERS CLAIMED THE BOMBING WAS IN RESPONSE TO THE UPCOMING TRIAL OF NAZI WAR CRIMINAL **KLAUS BARBIE**, WHICH IS SCHEDULED TO BE HELD LATER THIS YEAR IN LYON, FRANCE. A THIRD CLAIM WAS MADE IN THE NAME OF A PALESTINIAN GROUP AND TERMED A REPRISAL FOR ISRAEL'S IRON FIST POLICY IN SOUTHERN LEBANON. THE BOMBINGS TOOK PLACE NEAR PREVIOUS TERRORIST BOMBINGS OF A JEWISH RESTAURANT AND A JEWISH SCHOOL IN 1982.

B. (U) MEDITERRANEAN AREA.

1. (U) ITALY. THERE WERE NO TERRORIST INCIDENTS INVOLVING U.S. INTERESTS DURING THE REPORTING PERIOD; HOWEVER, THERE WERE SERIOUS INCIDENTS INVOLVING BOTH INDIGENOUS AND INTERNATIONAL TERRORISTS.

(A) (U) ON 21 MAR, TWO YOUNG MEN OF MEDITERRANEAN APPEARANCE OPENED FIRE WITH AUTOMATIC WEAPONS ON THE OFFICE OF THE ROYAL JORDANIAN AIRLINES IN ROME. THEY ALSO TOSSED TWO HANDGRENADES INTO THE OFFICES. FIVE PEOPLE WERE SERIOUSLY INJURED. THE ASSAILANTS FLED ON FOOT AND ESCAPED INTO A SUBWAY STATION. SIMILAR ATTACKS WERE CARRIED OUT AGAINST JORDANIAN INTERESTS IN NICOSIA AND ATHENS AT ABOUT THE SAME TIME. ALL THE INCIDENTS APPEAR TO BE A SPILL-OVER OF INCREASED TENSIONS IN THE NEAR EAST.

(B) (U) ON 24 MAR, POLICE IN THE NORTHERN ITALIAN CITY OF ALESSANDRIA ROUTINELY STOPPED A SUSPICIOUS VEHICLE TO CHECK THE IDENTITY OF THE FOUR OCCUPANTS. THEY STARTED SHOOTING AT THE POLICE, WHO RETURNED FIRE. TWO OF THE MEN IN THE VEHICLE WERE KILLED, ONE OF WHOM HAD A RECORD OF RIGHT-EXTREMIST CRIMES AND HAD BEEN RECENTLY RELEASED FROM PRISON. POLICE ALSO RECOVERED SEVERAL RIFLES, PISTOLS, AND GRENADES FROM THE VEHICLE. POLICE SAID ALL FOUR INDIVIDUALS (ONE FEMALE) WERE ASSOCIATED WITH THE NEO-FASCIST TERRORIST GROUP KNOWN AS THE ARMED REVOLUTIONARY CELLS (NUCLEI ARMATI RIVOLUZIONARI, NAR). USAREUR COMMENT: WHILE LEFTIST TERRORISTS HAVE GAINED MORE PUBLICITY IN ITALY, RIGHT EXTREMISTS HAVE SHOWN THEMSELVES EQUALLY LETHAL AND PERHAPS EVEN MORE DANGEROUS BECAUSE OF THE INDISCRIMINATE NATURE OF THEIR ATTACKS.

(C) (U) IN A MID-DAY ATTACK ON 27 MAR, TWO UNIDENTIFIED ASSAILANTS WALKED UP TO PROFESSOR EZIO TARANTELLI (AGE 43) ON THE GROUNDS OF THE UNIVERSITY OF ROME AND SHOT HIM TO DEATH AS HE WAS ENTERING HIS CAR. THE GUNMEN ESCAPED ON FOOT, LEAVING BEHIND A 71-PAGE RED BRIGADES (BR) DOCUMENT CRITICIZING THE POLICIES OF THE CRAXI

COALITION GOVERNMENT. TARANTELLI WAS A PROMINENT PROFESSOR OF LABOR ECONOMICS AND A TARGET OF THE LEFTIST PRESS BECAUSE OF HIS OPPOSITION TO THE ITALIAN SYSTEM OF AUTOMATIC COST-OF-LIVING PAY INCREASES INDEXED TO THE INFLATION RATE. THE MURDER OF TARANTELLI WAS THE FIRST MAJOR ACTION ATTRIBUTED TO THE BR SINCE THE 15 FEB 84 ASSASSINATION OF LEAMON R. HUNT, ALSO IN ROME.

(D) (C/NF) IN FEB 85, POLICE IN NORTHERN ITALY ARRESTED FIVE PERSONS ON SUSPICION OF TERRORIST-RELATED ACTIVITIES. IN SUBSEQUENT SEARCHES, NUMEROUS DOCUMENTS WERE FOUND RELATING TO WEST GERMAN, SPANISH, IRISH, AND FRENCH TERRORIST GROUPS AS WELL AS PHOTOGRAPHS OF SETAF HQ AND THE SETAF BASIC LOAD STORAGE AREA (BLSA). THE PHOTOGRAPHS, MEASURING 5" X 6" AND 6" X 9" RESPECTIVELY, WERE NOT ANNOTATED IN ANY WAY. QUANTITIES OF SOVIET PUBLICATIONS ALSO WERE FOUND AT A MARXIST-LENINIST INFORMATION CENTER NEAR VENICE. AUTHORITIES BELIEVE THE GROUP WAS IN THE INITIAL PLANNING STAGES OF A TERRORIST ACT AGAINST SETAF. WHILE POLICE DO NOT EXCLUDE THE POSSIBILITY OF OTHER FUGITIVES STILL BEIN& AT LARGE, THEY VIEW THE THREAT AS REDUCED AS THE RESULT OF THE ARRESTS.

2. (C) PORTUGAL. THE LEFTIST TERRORIST ORGANIZATION, POPULAR FORCES 25 APRIL (FP-25) STEPPED UP THE LEVEL OF ITS ACTIVITIES IN MAR 85. FOLLOWING A SERIES OF BOMBINGS ON 11 MAR (MANY OF WHICH WERE DIRECTED AGAINST FOREIGN RATHER THAN DOMESTIC TARGETS), FP-25 STAGED AN ASSASSINATION AND A PRISON ESCAPE ON 23 MAR. THESE ACTIVITIES SUGGEST AN ENHANCED OPERATIONAL CAPACITY AND RAISE CONCERNS ABOUT THE SECURITY OF U.S./NATO RELATED INSTALLATIONS IN PORTUGAL, PARTICULARLY SINCE FP-25 HAS BEEN TARGETIN& THESE FACILITIES.

3. (C) SPAIN. ON 7 MAR NEAR VITORIA, THE BASQUE TERRORIST ORGANIZATION, BASQUE FATHERLAND AND FREEDOM (ETA), ASSASSINATED THE CHIEF OF THE AUTONOMOUS BASQUE POLICE FORCE ONLY WEEKS AFTER THE CENTRAL GOVERNMENT AND THE BASQUE PROVINCIAL GOVERNMENT AGREED TO COOPERATE MORE CLOSELY TO END SEPARATIST STRIFE. SEVERAL DAYS LATER, ON 10 MAR, THREE POLICE OFFICERS AND TWO CIVILIANS WERE WOUNDED BY GUNFIRE FROM A PASSING AUTOMOBILE. ETA ALSO CLAIMED CREDIT FOR THIS ATTACK. ON 30 MAR IN ST. JEAN DE LUZ, FRANCE, A PROMINENT BASQUE JOURNALIST WAS ASSASSINATED BY THE RIGHTIST ANTITERRORIST LIBERATION GROUP (GAL). GAL HAS BEEN TARGETING BASQUE NATIONALISTS AND PEOPLE ASSOCIATED WITH ETA SINCE DEC 83. THE MURDER PROMPTED A NUMBER OF DEMONSTRATIONS AND SOME VIOLENCE. THE OTHER MAJOR TERRORIST ORGANIZATION IN SPAIN, FIRST OF OCTOBER GROUP OF ANTI-FASCIST RESISTANCE (GRAPO), WAS RELATIVELY INACTIVE DURING MARCH. HOWEVER, GRAPO REMAINS AS A POTENTIAL THREAT TO U.S. AND NATO INTERESTS IN SPAIN.

4. (U) GREECE.

(A) (U) AN UNIDENTIFIED PERSON THREW TWO SOVIET-MADE HANDGRENADES

(A) (U) ON 3 MAR 85, THREE MEMBERS OF THE SECRET ARMY FOR THE LIBERATION OF ARMENIA (ASALA) WERE SENTENCED FOR A TERRORIST ATTACK AGAINST THE TURKISH AIRLINES OFFICE AT THE ORLY INTERNATIONAL FLIGHT TERMINAL OUTSIDE OF PARIS. THE HEAD OF THE OPERATION, VAROUJAN GARBIDIAN, RECEIVED A LIFE SENTENCE, WHILE HIS TWO ACCOMPLICES, SONER NAYIR AND OHANNES SEMERCI, RECEIVED SENTENCES OF 15 AND 10 YEARS, RESPECTIVELY. THE ATTACK OCCURRED ON 15 JUL 83 AND RESULTED IN THE DEATH OF 8 PERSONS AND INJURIES TO 15 OTHERS. FOLLOWING A SERIES OF BOMBINGS ON 11 MAR (MANY OF WHICH WERE DIRECTED AGAINST FOREIGN RATHER THAN DOMESTIC TARGETS), FP-25 STAGED AN ASSASSINATION AND A PRISON ESCAPE ON 23 MAR. THESE ACTIVITIES SUGGEST AN ENHANCED OPERATIONAL CAPACITY AND RAISE CONCERNS ABOUT THE SECURITY OF U.S./NATO RELATED INSTALLATIONS IN PORTUGAL, PARTICULARLY SINCE FP-25 HAS BEEN TARGETING THESE FACILITIES.

3. (C) SPAIN. ON 7 MAR NEAR VITORIA, THE BASQUE TERRORIST ORGANIZATION, BASQUE FATHERLAND AND FREEDOM (ETA), ASSASSINATED THE CHIEF OF THE AUTONOMOUS BASQUE POLICE FORCE ONLY WEEKS AFTER THE CENTRAL GOVERNMENT AND THE BASQUE PROVINCIAL GOVERNMENT AGREED TO COOPERATE MORE CLOSELY TO END SEPARATIST STRIFE. SEVERAL DAYS LATER, ON 10 MAR, THREE POLICE OFFICERS AND TWO CIVILIANS WERE WOUNDED BY GUNFIRE FROM A PASSING AUTOMOBILE. ETA ALSO CLAIMED CREDIT FOR THIS ATTACK. ON 30 MAR IN ST. JEAN DE LUZ, FRANCE, A PROMINENT BASQUE JOURNALIST WAS ASSASSINATED BY THE RIGHTIST ANTITERRORIST LIBERATION GROUP (GAL). GAL HAS BEEN TARGETING BASQUE NATIONALISTS AND PEOPLE ASSOCIATED WITH ETA SINCE DEC 83. THE MURDER PROMPTED A NUMBER OF DEMONSTRATIONS AND SOME VIOLENCE. THE OTHER MAJOR TERRORIST ORGANIZATION IN SPAIN, FIRST OF OCTOBER GROUP OF ANTI-FASCIST RESISTANCE (GRAPO), WAS RELATIVELY INACTIVE DURING MARCH. HOWEVER, GRAPO REMAINS AS A POTENTIAL THREAT TO U.S. AND NATO INTERESTS IN SPAIN.
