THE LOCAL PRESS IN LYON HAS REPORTED THAT DUE TO THE DISCOVERY OF  
NEW EVIDENCE, SPECIFICALLY THAT 9 CHILDREN WERE AMONG THE 650  
PERSONS ON THE LAST DEPORTATION TRAIN OUT OF LYON ON AUGUST 11, 1944,  
THE TRIAL OF KLAUS BARBIE WILL BE POSTPONED. THE MINIMUM  
POSTPONEMENT MENTIONED IN THE PRESS IS SOME THREE WEEKS. MOST  
COMMENTARIES TALK ABOUT JANUARY, 1986 AS THE SOONEST DATE.  
ACCORDING TO AT LEAST ONE PRESS ACCOUNT, ON SEPTEMBER 6, THE DAY  
THAT MR. HUBERT OGIER, PRESIDENT OF THE CHAMBER DACCUSATION  
(GRAND JURY), WAS TO SIGN THE PROCESS FORWARDING BARBIES FILE TO  
THE COURT OF JURISDICTION, HE RECEIVED A LETTER FROM THE MINISTRY  
RESPONSIBLE FOR WAR VETERANS, DATED AUGUST 14, PROVIDING THE NEW  
EVIDENCE AND OBLIGING HIM TO RE-OPEN THE INVESTIGATION. THE PRESS  
IS ASKING, AS ARE OTHERS, WHY IT TOOK THREE WEEKS FOR THE LETTER  
TO REACH MR. OGIER? EVEN WORSE, SINCE INVESTIGATING MAGISTRATE  
CHRISTIAN RISS HAD WRITTEN TO THE MINISTRY UPON OPENING HIS  
INVESTIGATION IN VERY EARLY 1983, REQUESTING ALL THE INFORMATION  
THEY HAD, WHY DID THE MINISTRY ONLY RESPOND IN AUGUST, 1985?  
AS TO BE EXPECTED, JACQUES VERGES, BARBIES ATTORNEY, HAS BEEN  
INTERVIEWED IN SEVERAL NEWSPAPERS AND IS QUOTED AS SAYING THAT THIS
