2. JERUSALEM/WEST BANK NEWS:

ALL PAPERS REPORTED (6/5) THAT A BOMB EXPLODED ON
SATURDAY JULY 5 IN A QALQILYA RESTAURANT, WOUNDING 15
PEOPLE. AN IDF SPOKESMAN REPORTEDLY SAID THAT NINE OF
THE WOUNDED ARE JEWS, FIVE ARE ISRAELI ARABS, AND ONE,
ABDUL LATRIF HUSSEIN ABU HABA, IS A RESIDENT OF
QALQILYA. ACCORRDING TO "SECURITY SOURCES," AN ARAB MAN
LEFT THE EXPLOSIVE IN THE RESTAURANT AFTER HE ORDERED A
MEAL AND THEN STEPPED OUT TO BUY CIGARETTES. AFTER THE
BLAST, IDF TROOPS REPORTEDLY IMPOSED A CURFEW ON
QALQILYA, SET UP ROADBLOCKS, AND ARRESTED "DOZENS." THE
CURFEW WAS LIFTED LATER THE SAME AFTERNOON, THOUGH THE
STREET WHERE THE BOMBING OCCURRED REMAINED CLOSED OFF BY
TROOPS. QALQILYA MAYOR ABDEL RAHMAN ABU SNEINEH
"SHARPLY CONDEMNED THE BOMBING," THE POST REPORTED.

-- ALL PAPERS EXCEPT AL-FAJR REPORTED (7/7) THAT A
MOLOTOV COCKTAIL WAS THROWN AT AN ISRAELI CAR DRIVING ON
THE MAIN ROAD NEAR QALQILYA. NO ONE WAS INJURED AND NO
DAMAGE WAS CAUSED.

-- ALL ARABIC PAPERS EXCEPT AL-QUDS REPORTED (7/7) THAT

TWO MOLOTOV COCKTAILS WERE THROWN AT TWO ISRAELI VEHICLES TRAVELING THROUGH BEIT SAHOUR. NO DAMAGE OR INJURIES WERE REPORTED.

-- ALL ARABIC PAPERS EXCEPT AL-QUDS REPORTED (7/7) THAT STONES THROWN AT AN ISRAELI BUS IN HALHOUL CAUSED SLIGHT DAMAGE AND NO INJURIES.

THE POST REPORTED (7/7) COMMENTS BY COORDINATOR OF ACTIVITIES IN THE OCCUPIED TERRITORIES SHMUEL GOREN THAT WORK ON A PROPOSED ISRAELI WATER-DRILLING PROJECT NEAR BETHLEHEM WILL BEGIN ONLY IF ARAB WATER RIGHTS IN THE AREA ARE GUARANTEED IN A LEGALLY BINDING CONTRACT. GOREN REPORTEDLY CONFIRMED DETAILS OF THE PROJECT REPORTED EARLIER IN THE POST, AND CONCEDED THAT THE DEEP DRILLING SCHEME COULD DEplete WELLS SERVING ARAB COMMUNITIES IN THE AREA. GOREN REPORTEDLY SAID "IF ARAB RIGHTS ARE HARMED, WE WILL NOT ALLOW THIS PROJECT TO GET UNDERWAY." GOREN REPORTEDLY SAID THAT THE CIVIL ADMINISTRATION WOULD DEMAND COMPENSATION FOR ARAB COMMUNITIES IF THEIR WATER RATES INCREASE AS A RESULT OF THE PROJECT. HE SAID THAT LEGAL EXPERTS FROM THE DEFENSE MINISTRY AND THE WATER COMMISSION WERE CURRENTLY NEGOTIATING TERMS OF THE PROJECT. GOREN ADDED THAT U.S. OFFICIALS HAD CONTACTED HIS OFFICE ABOUT THE PROJECT, BUT THAT A COMPLETE EXPLANATION MUST WAIT FOR FINAL DETAILS TO BE WORKED OUT. IN OTHER RELATED STORIES:

-- AL-QUDS AND AN-NAHAR ADDED THAT JORDAN COMPLAINED TO THE UNITED NATIONS ABOUT THE ISRAELI PLAN TO DRILL FOR WATER IN THE WEST BANK.

-- THE POST CARRIED AN AP WIRE SERVICE STORY FROM EGYPT REPORTING THAT THE EGYPTIAN FOREIGN MINISTRY COMPLAINED TO ISRAEL THAT REPORTED PLANS TO DRILL A WELL NEAR BETHLEHEM AND PIPE WATER TO JERUSALEM CONSTITUTE A VIOLATION OF INTERNATIONAL LAW. ACCORDING TO THE STORY, THE ISRAELI CHARGE D'AFFAIRS WAS SUMMONED TO THE FOREIGN MIWISTRY AND TOLD THAT EGYPT "STRONGLY CONDEMNS AND IS VERY WORRIED" ABOUT THE PROJECT. ACCORDING TO THE REPORT, THE ISRAELI FOREIGN MINISTRY SPOKESMAN REFUSED TO COMMENT ON THE EGYPTIAN MOVE.

-- AL-QUDS, ASHAAB, AND AN-NAHAR REPORTED THAT MAHMOUD IBRAHIM ASSALEH, HEAD OF THE AGRICULTURAL COOPERATIVE SOCIETY OF AL-AWJA CLAIMS THAT ONE THOUSAND DUNAMS OF LAND WHICH ARE PLANTED WITH BANANAS IN EL-AWJA NEAR JERICHO ARE THREATENED BY DROUGHT. THIS IS DUE TO A

LOWERING IN THE WATER TABLE OF THE SUBTERRANEAN WELLS IN THE AREA. THE SOCIETY DEMANDED A PERMIT TO DRILL FOR AN ARTESIAN WELL IN THE AREA.

ALL PAPERS EXCEPT AL-QUDS REPORTED (7/6) THAT JERUSALEM MAYOR TEDDY KOLLEK AND OTHER TOP CITY OFFICIALS WILL NOT ATTEND JULY 14 CELEBRATIONS AT THE FRENCH CONSULATE IN PROTEST AGAINST THE CONSULATE'S PLANS TO HOLD TWO SEPARATE RECEPTIONS, ONE FOR JEWS AND ONE FOR ARABS. A MUNICIPALITY SPOKESMAN SAID, "IT'S AS IF THEY'RE DIVIDING THE CITY IN TWO. THERE MAY BE A POLITICAL ARGUMENT OVER SOVEREIGNTY IN THE CITY, BUT EVEN ANWAR SADAT SAID THAT THE CITY SHOULD REMAIN UNIFIED."

THE POST REPORTED (7/6) THAT "U.S. CONSUL GENERAL MORRIS DRAPER AND MRS. ROBERTA DRAPER WELCOMED SCORES OF GUESTS FROM BOTH PARTS OF JERUSALEM, AS WELL AS FROM THE WEST BANK AND GAZA," DURING AN INDEPENDENCE DAY CELEBRATION AT THE AMERICAN CONSULATE. THE POST ADDED THAT "UNTIL A FEW YEARS AGO," THE CONSULATE HELD TWO SEPARATE JULY 4TH RECEPTIONS. "BUT THE AMERICANS CHANGED THEIR POLICY, AND YESTERDAY'S INDEPENDENCE DAY RECEPTION AT THE AMERICAN CONSUL'S WEST JERUSALEM RESIDENCE DREW A NUMBER UNCLAS SECTION 03 OF 06 JERUSALEM 02055

OF PALESTINIANS, MOST OF THEM FROM THE PRO-JORDANIAN CAMP."

LAWYER ZIAD ABU ZIAD, EDITOR OF GESHER, A HEBREW LANGAUGE ARAB PAPER, TOLD AL-FAJR (7/7) IN AN INTERVIEW THAT CONSULATES IN JERUSALEM PERFORM POLITICAL FUNCTIONS SINCE THEY ARE COMMITTED TO UPHOLDING THE STATUS QUO PRIOR TO THE ISRAELI OCCUPATION OF 1967 AND AVOIDING IMPLIED RECOGNITION OF JERUSALEM'S ANNEXATION. ZIAD CLAIMED THAT "IT IS KNOWN THAT AMERICAN CONSUL MORRIS DRAPER IS TRYING TO CREATE A RAPPROCHEMENT BETWEEN ARABS AND JEWS IN THE CITY." ZIAD SAID THAT GOOD INTENTIONS DO NOT JUSTIFY THE POLITICAL EFFECTS OF SUCH MEETINGS. "CONSUL GENERAL DRAPER HAS A HIGH OFFICIAL POSITION, AND HE DOESN'T HAVE A RIGHT TO MIX HIS PERSONAL OPINIONS WITH THE POLITICAL SENSITIVITIES OF THE CITY." ZIAD SAID THAT NOT MANY PALESTINIANS ATTENDED THE FOURTH OF JULY PARTY AT THE CONSULATE, AND THAT THEIR ATTENDANCE DOES NOT CONSTITUTE RECOGNITION OF THE AMERICAN "NORMALIZATION POLICY" WHICH MAY HAVE BEEN ADOPTED BY THE U.S.

THE POST REPORTED (7/7) THAT THE JERUSALEM MUNICIPALITY

TOOK FORMER ASHKENAZI CHIEF RABBI SHLOMO GOREN TO COURT YESTERDAY TO FORCE HIM TO TAKE DOWN THE YA'AKOV AGAM HOLOCAUST MEMORIAL ERECTED ON THE ROOF OF HIS IDRA RELIGIOUS INSTITUTE OVERLOOKING THE WESTERN WALL IN JERUSALEM'S OLD CITY. GOREN REPORTEDLY CONDEMNED THE CITY'S MOVE AS "A BLATANTLY ANTI-SEMITIC ACT STEMMING FROM HATRED OF RELIGION, AND CLAIMED THAT IT WOULD "AROUSE JEWS THROUGHOUT THE WORLD." THE POST REPORTED THAT MUNICIPALITY OFFICIALS RESPONDED THAT GOREN WAS USING PUBLIC SENSITIVITY TOWARDS THE HOLOCAUST TO COVER UP THE FACT THAT HE WAS BREAKING THE LAW BY NOT OBTAINING A BUILDING PERMIT FROM THE CITY. MAYOR TEDDY KOLLEK REPORTEDLY SAID, "RABBI GOREN WASN'T AUTHORIZED TO ESTABLISH FOR ALL THE JEWISH PEOPLE A MEMORIAL TO THE SIX MILLION. WHY HIM AND NOT EVERYONE ELSE WHO HAS A BUILDING SURROUNDING THE WESTERN WALL AS WELL?" ACCORDING TO THE POST, THE CHARGE SHEET FILED BY THE CITY STATES THAT GOREN DID NOT GET A PERMIT FROM THE LOCAL PLANNING COMMITTEE. THE MEMORIAL WAS DEDICATED ON APRIL 22 IN THE PRESENCE OF KOLLEK, FOREIGN MINISTER SHIMON PERES AND PRIME MINISTER SHAMIR.

AL-QUDS AND AN-NAHAR REPORTED THAT THE MOSLEM TRUST FUND (WAQF) SUBMITTED A SWORN AFFADAVIT TO THE ISRAELI HIGH COURT OF JUSTICE IN REPLY TO A PETITION PRESENTED BY THE EXTREMIST JEWISH GROUP, THE FAITHFUL OF THE TEMPLE MOUNT, IN WHICH THEY CLAIMED THAT THE ISLAMIC WAQF IS UNDERTAKING ILLEGAL CONSTRUCTION INSIDE THE MOSQUE AREA. BOTH THE JEWISH GROUP AND THE DEFENDENTS, THE JERUSALEM MUNICIPALITY, THE MINISTRIES OF EDUCATION AND POLICE, AND THE ISRAELI GOVERNMENT ARCHAEOLOGY DEPARTMENT AGREE THAT THE COURT'S PRESIDING OVER THE CASE DOES NOT CONSTITUTE RECOGNITION OF THE WAQF'S SOVEREIGNTY OVER THE TEMPLE MOUNT AREA. AN-NAHAR REPORTED THAT SHEIKH SAAD EDDIN AL-ALAMI SAID THAT HE WILL TRY TO PROTECT MOSQUE PROPERTY AND THAT THE ISRAELI COURT HAS NO JURISDICTION OVER MOSLEM HOLY PLACES. HE CLAIMED THAT HIS POSITION WAS APPROVED BY THE JORDANIAN GOVERNMENT IN COORDINATION WITH THE ISLAMIC COUNTRIES.

ALL PAPERS REPORTED (7/7) THAT THE CAIRO-AMMAN BANK, THE ONLY ARAB BANK OPERATING IN THE TERRITORIES, WILL OPEN TWO MORE BRANCHES THIS MONTH, IN HEBRON AND RAMALLAH, TO COMPLEMENT THE NABLUS OFFICE WHICH OPENED LAST YEAR.

POSSIBLE SITES FOR THE NEW BRANCHES. THE POST WRITES THAT REUTERS REPORTED THAT ADDITIONAL OFFICES WILL BE OPENED BEFORE THE END OF THE YEAR, ONE OF THEM IN JENIN.

ALL ARABIC PAPERS REPORTED (7/7) THAT ISRAELI AUTHORITIES BUILT A CEMENT WALL AT THE WESTERN ENTRANCE OF THE BALATA REFUGEE CAMP IN NABLUS. THE WALL WAS REPORTEDLY BUILT IN RESPONSE TO INCIDENTS OF ROCK THROWING FROM THE CAMP, WHICH INJURED ONE ISRAELI. AL-QUDS AND ASHAAB REPORTED (7/7) THAT ISRAELI AUTHORITIES RENEWED FOR THE SECOND TIME A SIX MONTH TOWN ARREST ORDER AGAINST UNIONIST OMAR AHMAD ABDEL LATIF, 30, OF BATIR VILLAGE IN THE BETHLEHEM DISTRICT.

ALL ARABIC PAPERS REPORTED THAT THE MILITARY APPEALS COMMITTEE APPROVED THE SIX MONTH ADMINISTRATIVE DETENTION ORDERS ISSUED AGAINST DOCOTR THABET AHMED THABET, 35, OF TULKARAM; NIDAL MOHAMMAD ABUD LAFI, 23, A STUDENT AT AN-NAJAH UNIVERSITY IN NABLUS; AND JIHAD SHAKER MISHEH, 25, OF BALATA REFUGEE CAMP NEAR NABLUS. AL-FAJR (7/7) REPORTED THAT SEVERAL WOMEN AND CHILDREN WERE "VICTIMS OF ISRAELI SOLDIERS' AGRESSION" DURING A SEARCH IN THE BALATA REFUGEE CAMP LAST MONTH." THE REPORT REPRINTED FROM THE HEBREW LANGUAGE ARAB PAPER GESHER, ADDED THAT THE MAJORITY OF THE INJURED WERE CHILDREN WHO WERE HIT BY RUBBER BULLETS IN "SENSITIVE PARTS OF THEIR BODIES." THE ALLEGATIONS WERE MADE BY CAMP RESIDENTS IN JERUSALEM. AL-FAJR PRINTED A PHOTOGRAPH ON PAGE ONE OF A SEVEN YEAR OLD BALATA GIRL SHOWING SCARS FROM RUBBER BULLET WOUNDS IN HER UPPER CHEST.

ALL ARABIC PAPERS REPORTED (7/4) THAT ISRAELI AUTHORITIES ORDERED CLOSURE OF AN-NAJAH UNIVERSITY IN NABLUS FOR ONE DAY, JULY 4, AFTER INFORMATION WAS RECEIVED INDICATING THE POSSIBILITY OF DISTURBANCES AND DEMONSTRATIONS BY UNIVERSITY STUDENTS ON THE OCCASION OF PALESTINE WEEK.

AL-QUDS, ASHAAB, AND AN-NAHAR (7/4) REPORTED THAT AMNESTY INTERNATIONAL CONSIDERS THE ADMINISTRATIVE ARREST OF FEISAL HUSSEINI "AN UNJUST ARREST," AND THAT HE IS CONSIDERED "A PRISONER OF CONSCIENCE." AFTER UNCLAS SECTION 05 OF 06 JERUSALEM 02055

THE COMPLAINTS CONCERN THE FUTURE OF THE LAND, PEOPLE AND NATURAL RESOURCES. ISRAEL MUST TREAT PALESTINIANS AS A PEOPLE WHO HAVE RIGHTS AND ROOTS.

THE POST WRITES (7/6) THAT IN TAKING CREDIT FOR THE ATTACK ON QALQILYA, THE PLO NOT ONLY HOPES TO DESTROY NEIGHBORLY RELATIONS BETWEEN JEWS AND ARABS THERE, BUT ALSO TO "PUT PRESSURE ON ISRAEL TO ACCEPT THE PLO AS A PARTNER TO A BOGUS PEACE, AND SCURRY OUT OF THE TERRITORIES BACK TO THE OLD ARMISTICE LINES -- AS A UNCLAS SECTION 06 OF 06 JERUSALEM 02055

PRELUDE TO THE EVENTUAL TAKEOVER BY THE PLO OF ALL PALESTINE." YET SUCH ACTIONS BROADEN THE APPEAL INSIDE ISRAEL OF THE "ANNEXATIONIST SUPER-PATRIOTS" WHO WOULD SOLVE THE "ARAB PROBLEM" IN THE WEST BANK AND GAZA BY WAY OF "WHOLESALE EXPULSION" TO JORDAN.

AL-FAJR (7/4) WRITES THAT THE ARAB COUNTRIES WHICH HAVE BEEN UNABLE TO HOLD A LONG-AJOURNED ARAB SUMMIT AND WHICH CANNOT REACH A UNITED ARAB POSITION ON THE PALESTINAIN POSITION ARE NOT QUALIFIED TO CRITICIZE THE EUROPEAN POSITION. WESTERN EUROPE IS DEEPLY PREOCCUPIED WITH ITS OWN FINANCIAL DIFFICULTIES AND CANNOT DEVIATE FROM THE AMERICAN POLCIY ON THE MIDDLE EAST.
