



ATTACHMENT B TO EGOW - 1830

Brief Personal History on Hildegard PURWIN []

Since the complete file on Subject is in Headquarters, we shall briefly synopsize the past history for COS and Bonn. The PRQ Part I (Attachment A to EGOW-1830) partially supplements the information below.

Hildegard PURWIN entered the SD in 1939, serving in Weimar until March 1940 when she was transferred to Amt VI, RSHA (Reichsicherheitshauptamt). She worked as interpreter and translator of Italian at both the Rome and Berlin offices up to September 1943, when she was chosen to become an Agent. Her chief was Dr. Wilhelm ROETTL; she was assigned as secretary to the Italian Foreign Minister Count Galeazzo CIANO, then under house arrest at Allmannshausen/Starnbergersee, with instructions to report his activities to Amt VI.

She grew fond of CIANO, who had been transferred to prison at Verona, Italy and in October 1943 she decided to help him. She claimed that through her efforts CIANO's diary and several documents pertaining to Italo-German relations were kept from falling into the hands of the SD. She assisted CIANO's wife Edda MUSSOLINI in her escape to Switzerland. Upon her own request she was transferred back to Weimar in October 1944 where she continued her original work of translating and interpreting.

After her arrest by the Americans in June 1945 and interrogation, she was employed by (the then) KUBARK until 1951 in the following successive capacities:

- 1) Informant on former RSHA personalities and activities
- 2) "Sitting duck" Operation - She was employed in ONCUB, Berlin, to attract Russian recruitment approaches. This operation was unsuccessful.
- 3) She worked for CANLET in Berlin (the job was obtained for her by us) and later became head of the Frankfurt Bureau of his newspaper. She knew of CANLET's relationship with KUBARK and he knew of hers.
- 4) Information source in Bonn while acting as newspaper correspondent there. She had contacts in the SPD, labor, governmental and diplomatic circles. She had access to Thomas BEHLER, and (Per the former Case Officer, [] EOPW-3312, 13 December 1956) in the course of her years in Bonn she became a close friend and confident of [] learning from him about our support of [] Through CANLET she had been aware of [] Dr. Kurt SCHUMACHER []

KUBARK's formal tie with Subject was terminated amicably in December 1951, around the time of her marriage to Carl Heinz PURWIN, because of her increased attention to household duties and because she was rated a rather unproductive source.

For the record, in the years 1945-1951, Hildegard PURWIN (then BEEZY) had met or known socially the following KUBARKers: []

and others briefly.

It should be noted, from the following trace, that UPHILL is aware that there was a relationship between KUBARK and Hildegard PURWIN, at one time: MUNI 7048, 1 May 1958, stated that a 1954 report from Werner NIEKE [] to UPHILL listed Hildegard BLUM as working for [] in Frankfurt.

[] attended Bremen Mayor Wilhem KAISEN's reception for the Bonn press on 19 March 1959. He subsequently reported on his [] conversation with [] on the SPD reunification plan and noted that Hildegard PURWIN, "a close friend of []" also took part in this conversation. [] did not elaborate on PURWIN (EGFA-26164, 21 April 1959, Att. B)

Hildegard PURWIN also has the confidence of [] as she described to [] when they met in Geneva in May/June 1959. (See EGFA-26980, 19 June 1959)

Dr. Carl Heinz PURWIN

(DPOB: 6 February 1915, Koenigsberg, Germany)

Carl Heinz PURWIN was a pre-Hitler Social Democrat; he was drafted into the German Army in WW II and sent to France, where he promptly deserted and joined the Maquis. In 1944, following the liberation of Southern France by the U.S. 7th Army, PURWIN worked for the Army's Special Service Division, organizing traveling shows, along USO lines. After the war he worked on various British Zone newspapers and since 1947 he has been with the DOB. On 1 December 1951 he married Hildegard BEETZ and they have been living in Bonn since then. (MIPA-5911, 14 December 1951)

"In a memorandum to the Chief, PEMIGHT, dated 2 August 1951 [] recommended (Karl Heinz PURWIN) and (Colonel Konrad STEPHANUS) as possible resistance leaders. As per memorandum from [] Chief, QKFENCE, dated 8 August 1951, [] was authorized to make the contacts. Although (STEPHANUS) was located by [] no contact could be made due to lack of any introductory contact or information. Before attempting again to make contact, [] requests that he receive from [] additional information about the two subjects. This information should include, if possible, a suggestion as to how such contact may be made. /s/ []" (1654 CFRPG, 1 October 1951 quoted in toto; repeated in toto in EGFW-3311, 13 December 1956)

According to a "List of arrivals of foreign newspaper correspondents in Trieste for the period June - September 1952, Memo dated 8 August 1952, Karl PURWIN, (DPOB as above), German citizen, Passport # 0505783 issued in Duesseldorf on 11 November 1950, arrived in Trieste on 7 August 1952 from Bonn; Hildegard PURWIN also arrived on the same day, from Bonn. (SITA-159, 22 December 1952, quoted in EGFW-3311)

CAVATA traced Dr. Carl Heinz PURWIN (DPOB as above) with UPHILL in 1953, but the reason for the trace is not indicated in Headquarters files. (EOLA-4021, 10 June 1953)

Viktor Herbert SCHNEIDER [], the convicted MFS Agent, reported at the time of his interrogations that he had been ordered by the MFS to report to them the names of all his CDU and journalist acquaintances in the Bonn area; SCHNEIDER did this and included among these men PURWIN. The MFS then told him to assess certain of them, including PURWIN. SCHNEIDER acted upon this order and reported to the MFS that PURWIN was "an excessive drinker, given to extra-marital affairs and probably approachable by the MFS. PURWIN's wife is named Hilde." Our files do not indicate whether or not it is known if the MFS did (or have recently) contacted PURWIN. (BRUS 1759, 25 April 1958; MUNI 7048, 1 May 1958; EGQA-98725, 13 May 1958 summary; EGW-6176, 7 June 1958)
