<p>1. Additional copies of subject articles, already summarized in References C and D, are forwarded for your information.</p> <p>2. You will notice that neither article makes any reference to the "Open Letter to Chairman Khrushchev" by the U.S. National Committee for a Sane Nuclear Policy. This is due (a) to the fact that this material had not yet become available to us when we met CAMISE, and (b) to the fact that this statement, per se, is of little interest in Germany and could, therefore, not be woven into the interviews by CAMISE, who told us at the time of the briefing that she would have to put her interviews within the context of the Kennedy-Khrushchev meeting in Vienna as it pertains to Germany, but that she would attempt to cover the requested subject by provoking answers on the Soviet veto demand.</p> <p>3. It is our impression that CAMISE did all she could in light of her assignment and the local situation.</p> <p>4. If any of the addressees exploit the attached articles further, we would be interested in hearing about it.</p>
