



<p>1. Your attention is called to the third paragraph of Embassy Telegram No. 2411 to the Department, dated 24 December 1964 and reporting on German press reactions to the synthetic fiber plant controversy. This paragraph highlights the editorial reaction by one German paper which was more favorable to the American position than that of most other papers that day.</p> <p>2. The operational background is as follows. CAMISE called us during the afternoon of 23 December and asked for a briefing on the controversy. We called her back after obtaining the facts and the Washington press guidance from the Press Attache. She thanked us for the clarification. At the tailend of the conversation we asked whether she could place an editorial, or get one of the editors to write one, designed to calm the troubled waters or at least take some of the heat off the United States. She said she would try. The next day's edition of her paper included her news story and a lead editorial on this problem, signed by one of her colleagues but (according to CAMISE) written by her. Both were factual and in line with what was then desired.</p> <p>3. No great shakes, as the continuing furor shows. However, it does indicate the value of maintaining friendly relations with the Bonn journalistic community.</p> <p>4. The case officer does not see CAMISE frequently, nor is that necessary for the occasional ad hoc manner in which her services are utilized. We have lunch with her every couple of months or so, meet here and there during conferences and conventions of CABAKER or CABAKER-affiliated organizations, and phone one another when some pertinent question arises.
