1. APPRECIATE REF BUT SUGGEST THAT IT MAY HAVE MISSED THE POINT.
2. CAMISE IS STILL CONSIDERED ACTIVE CLANDESTINE ASSET OF [ ] STATION. THEREFORE NEITHER STATION NOR SHE HAS ANY INTEREST IN HAVING OVERT CORRESPONDENCE WITH THE AGENCY. FURTHERMORE, CAMISE'S PRESENT LEGAL NAME IS DIFFERENT FROM THE NAME WHICH SHE HAD DURING WORLD WAR TWO AND IMMEDIATE POST-WAR ACTIVITIES. IT WOULD BE CERTAINLY DISADVANTAGEOUS AND POSSIBLY EMBARRASSING FOR CAMISE'S PRESENT IDENTITY TO BE CONNECTED IN OVERT CORRESPONDENCE WITH THE WORLD WAR TWO EVENTS.
3. SINCE CAMISE TURNED HER DOCUMENTS OVER TO A U.S. OFFICIAL IN ACCORDANCE WITH THAT OFFICIAL'S INSTRUCTIONS AND AS PART OF A CONSPIRATIVE RELATIONSHIP, WE BELIEVE IT ONLY FAIR THAT HER DOCUMENTS BE RETURNED TO HER THROUGH SIMILAR CHANNELS.
4. WOULD APPRECIATE ANYTHING HQS MAY BE ABLE TO DO TO EXPEDITE THIS MATTER.
