1. WHAT DATE DID OPPENHEIM SEND CASH TO LUCIE JOHN?
2. ON BASIS UTILITY STATEMENT THAT UJDOWN, A UJDRIZZLY PERSONALITY, INTENDED VISIT MUNICH WEEK OF 19 SEPT 54 AND WOULD PROBABLY CONTACT DR. JOSEF MUELLER, WE PUT 24 HOUR CIS COVERAGE ON MUELLER.
3. NO INDICATION UJDOWN VISITED MUELLER, BUT ON 23 SEPT MUELLER CALLED BARON VON OPPENHEIM AT KOELN PHONE 32904. OPPENHEIM WAS NOT AT HOME AND MUELLER REQUESTED SERVANT TO INFORM OPPENHEIM THAT MUELLER WOULD MEET OPPENHEIM AT THE BANK IN KOELN 1900 HOURS 24 SEPT.
4. IF UTILITY SUSPICIOUS RE UJDOWN WELL FOUNDED, ABOVE COULD POSSIBLY BE OTTO TO LUCIE CHANNEL.
5. FULL REPORT ON UJDOWN BEING PREPARED.
6. UTILITY 10 DAYS AGO CITED BONN 2080 PARA 3 STORY TO  
 AS EXAMPLE DIFFICULTIES BRUECHNER FACES IN DISCHARGING
