- [] REPORTS BEISSNER WAS HIS GUEST IN DAMA DURING PERIOD 9-14 MARCH. HE CONTACTED BEISSNER THROUGH RADEMACHER. USED COVER STORY HE AWARE TENTATIVE SA'UDI PROJECT ESTABLISH RADAR NETWORK, THAT 10 MILLION STERLING SET ASIDE FOR PROJECT AND HE TRYING WORK WAY IN AS MIDDLE MAN. [] STATES SA'UDIS WERE CONSIDERING PROJECT THIS TYPE THREE-FOUR MONTHS AGO.) CLAIMS BEISSNER SAID HE COULD OBTAIN EQUIPMENT AND GAVE HIM SOME GENERAL COST ESTIMATES.
- [] ALSO TOLD BEISSNER THAT IN LIGHT UAR HE INTERESTED IN TRYING ESTABLISH OFFICE CAIR AND ASKED IF IT POSSIBLE FOR HIM SET UP SMALL OFFICE IN BEISSNER ESTABLISHMENT ON COST SHARING BASIS. BEISSNER TENTATIVELY AGREED, BUT SAID WOULD HAVE DISCUSS FURTHER.
- WARWICK VERY IMPRESSED WITH BEISSNER ACUMEN. SAID BEISSNER GAVE (PORTION GARBLED BEING SERVICED) CONTACTS, BUT KEPT DISCUSSIONS HIS BUSINESS ACTIVITIES ON ON VERY GENERAL LEVEL. [] NOT CLAIMING REIMBURSEMENT FOR BEISSNER VISIT. BUT WISHES KNOW IF WE WOULD LIKE HIM GO CAIR IN EFFORT DEVELOPE MORE SPECIFIC INFO RE BEISSNER SET UP AND ACTIVITIES THERE AND PURSUE POSSIBILITY EFFECTING BUSINESS RELATIONSHIP WITH HIM.
