

1. For inclusion in Headquarters files we attach a copy of a statement (both in original German and English translation) which BILLMAIER prepared voluntarily for the consular section of the embassy to help clear himself and, hopefully, avoid future difficulties regarding his U.S. visa.

2. The embassy has in the meantime received a report from the Department containing information from KUBARK Headquarters. On the basis of this report the Embassy again contacted us and we advised them, after checking with the SG, that investigative authorities have completed their investigation of Subject and forwarded the results to the GBA for disposition. The SG considers it very likely that the GBA will be satisfied that Subject's activities on behalf of the Poles were properly coordinated with German authorities at the time and will drop charges against him.
