Before me the undersigned, authorized by law to administer oaths in cases of this character, personally appeared one PETER N. NEMETH, Tec 5, 33 139 646, who after being duly sworn deposes and says:

"I worked for Major Bishop from 15 November 1944 until his departure from Bucharest in the capacity of general clerk. There was a shredding machine on the second floor of the Otetari Building in the main hallway which was used for the disposition of classified documents. The maids took the remains out and what disposition they made of them I do not know.

I was working the day that Major Bishop was notified to leave by plane, but I was not in the office at the time the telephone call came in. I saw Major Bishop in the office about 1:30 that afternoon. He said that he was to have taken the 1 o'clock plane that day and that he had missed it due to an important interview.

I met Elisabeth Mezey-Feher while she was living at the OSS billet at Dumbrava Rosu Number 6. She understood every-day English conversation spoken at the normal rate of speed. I had dinner at the table with her on several occasions and it was not necessary to speak slowly in order for her to understand everything we said."

Before me the undersigned, authorized by law to administer oaths in cases of this character, personally appeared one SYLVIA PRESS, American civilian, who after being duly sworn deposes and says:

"Elisabeth Mezey-Feher (Jocky Cristea) frequently ate with Major Robert Bishop in the OSS mess and was present when matters pertaining to the work of the organization were discussed. She was familiar with the names of some agents doing undercover work for the organization and also with the names of many OSS Army officers in Bari, Turkey and other places.

It was common gossip in Bucharest that Elisabeth Mezey-Feher had been on friendly relations with the Nazis prior to Allied occupation and it was reported that on two known occasions she had been an informer resulting in sending Rumanians to German concentration camps."
