MEMORANDUM OF ORAL AGREEMENT

DATE: 14 March 1966

TO : Chief, SR
VIA : Contract Approving Officer
FROM : Chief of Base, Hamburg
SUBJECT : Engagement of AECONFIDE/1 as Independent Contractor

1. Term and Project Charge. Subject individual has been engaged under oral contract under SR OOA. The effective date of the oral contract is 1 October 1965, and shall continue thereafter for an indefinite period, subject to termination by ODYOKE upon 30 days actual notice.

2. Security Approval. The appropriate security approval for Subject's use has been obtained. Type POA Date 20 Oct 1965.

3. Citizenship. Subject is a foreign national.

4. Compensation. Subject will be paid DM 350.00 per month. The approximate equivalent of this amount in PBPRIME currency is 87.50 dollars. Subject will be reimbursed for authorized operational travel and entertainment. The above mentioned retainer was valid for the period Oct-Dec 1965 (trial period). A moderate raise effective January 1, 1966, will still have to be negotiated with Subject in accordance with our original agreement of 1 October 1965.
