1. <u>Communications:</u>		
<p>a. [] [] Subject's Case Officer, handled him during the major part of this period, whereas [] (Alternate Case Officer) had only one meeting with him (26 June 70) when [] was on Annual Leave.</p> <p>b. Meetings with Subject took place in various restaurants in Kiel and Hamburg, and were prearranged. Emergency meetings were arranged via telephone.</p>		
2. <u>Production:</u> Support Activities (see para 3 below)		
3. <u>Operational:</u>		
<p>a. Subject fulfilled numerous tasks in support of our operations directed against AEGLOBE personnel and their steady contacts in AEPLIMSOLL. The major part of such activities consisted of surveillance, neighborhood and records checks, which provided us with interesting and useful operational information. Worth mentioning in this respect are Identity 1 and Identity 2, who are in the habit of contacting and entertaining visiting AEGLOBERS, and we are speculating on the possibility that Identity 1 is carrying out SK functions.</p>

b. Parallel with the above-mentioned activities, Subject continued to widen his net of informants in AEPLINSOLL, in the City, and at the Canal. He is currently cultivating two AEPLINSOLL employees who are in a position to report on the activities and movements of AEGLOHRS, and whom we would like to add to the circle of Subject's unwitting sub-sources. (Note: We are going to request POAs as soon as Subject has finished his assessment of these individuals and provided us with complete background data.)

4. Security: Nothing to report.

5. Administrative:

Subject will take Annual Leave during the period 18 July - 20 August 1970.

6. Financial:

Subject was paid DM 420.- per month, and was reimbursed for his operational expenditures.

7. Comments:

As before, Subject continued to be an industrious and trust-worthy asset who accepted and fulfilled all tasks successfully and with great enthusiasm.
