MARTIN BORMANN

On March 4, 1965, the Resident Agency, Federal Bureau of Investigation, Cocoa, Florida, received a letter dated March 3, 1965 from SALLY TOUCHETTE, 2761 Pine Ridge Drive, Titusville, Florida, in which she indicated that she knew the whereabouts of MARTIN BORMANN, a convicted Nazi war criminal.

On March 4, 1965, SALLY TOUCHETTE advised that while she was watching TV recently, she recognized a photograph of MARTIN BORMANN as being identical with an individual she once knew in Corvallis, Oregon, as KURT WOLFE. She advised that the photograph appeared in the advertisement in conjunction with an article, entitled, "World's Most Wanted Criminal", appearing in the March, 1965 issue of the "Readers Digest".

SALLY TOUCHETTE advised that she was once employed as a checker in a small neighborhood grocery store, Hill's Market, 29th Street, Corvallis, Oregon, until she resigned her position on October, 1961, due to her pregnancy. She advised that the grocery store had a customer that she knew as KURT WOLFE, a laborer, employed by Chapwood, Inc., a fiberboard manufacturing mill in a small town near Corvallis, Oregon. She advised that she distinctly recalled WOLFE as being a strange, lonely, and dispassionate looking man. She advised that he frequently stopped at the store to buy groceries and on these occasions was drawn into political discussions with a co-worker, ROBERT (Last Name Unknown), a political science major at Oregon State University. Mrs. TOUCHETTE advised that during these political discussions, she recalled that Mr. WOLFE indicated that he was a former Nazi and a member of the SS. She recalled that on one occasion, he became highly agitated at a magazine on the newsstand that dealt primarily with the German Concentration Camps during World War II. She described WOLFE as being a white male, 60 years of age at

the time, 5'8", 165 pounds, stocky build, occupation - laborer, Chapwood, Inc.

Mrs. TOUCHETTE advised that she had not read the recent article appearing in the "Readers Digest" and did not have any knowledge as to its contents. She advised that when the photograph appeared on the television set, she recognized it as being identical to the individual she knew as KURT WOLFE. She further advised that Hills Market maintained records of its credit customers and that the market should have the current address for KURT WOLFE. She advised that to the best of her knowledge, WOLFE was not married and did not have any close associates. She advised that WOLFE never spoke to anyone at the store and it was rumored that he had few, if any, friends at the Chapwood Plant. Mrs. TOUCHETTE advised that when she worked for Hills Market, she was employed under the name Mrs. DEAN PRIDDY. She advised that she did not make the association of KURT WOLFE and MARTIN BORMANN until she saw BORMANN's photograph on the television set. Until that time, she advised, she considered WOLFE to be a discontent immigrant who longed to return to his native land.
