MARTIN BORMANN

On April 26, 1955, Mrs. GERTRUDE YANCY, who is eighty years of age and resides at 1202 West Kirk Place, San Antonio, Texas, advised a Special Agent of the FBI that she had recently read an article in the March, 1965, issue of Reader's Digest pertaining to the above-captioned individual. She stated this reminded her of an incident which happened during World War II and she stated that she wanted to report this matter to the FBI in the event it was of some help. She related the following information:

During World War II she became associated with a Mrs. EDNA QUIN who formerly lived on Thompson Place in San Antonio. Mrs. YANCY and Mrs. QUIN served on the same election board on several occasions. She recalls that on one occasion, the exact date or year unrecalled, in a conversation with Mrs. QUIN, Mrs. QUIN stated that she had been married to a man in Germany. As a result of this marriage, she bore a young son and subsequently came to the United States with this son. The son's name was MARTIN.

After being in the United States for some time, Mrs. QUIN's husband, according to Mrs. QUIN, came to the United States and obtained their son MARTIN and returned MARTIN to Germany. Mrs. QUIN subsequently divorced her husband in Germany and married another man by the name of QUIN who resided in San Antonio. Mrs. QUIN's husband formerly worked in some capacity at the Bexar County Courthouse in San Antonio.

MARTIN BORMANN

Mrs. YANCY stated that approximately five or six years previously Mrs. QUIN died. A year or two before Mrs. QUIN died, her husband, (first name unknown) QUIN, died.

Mrs. YANCY stated that the only individual whom she could recall that might have some information regarding Mrs. QUIN's background was a cousin in New Braunfels, Texas, who is an undertaker. Mrs. YANCY does not know this cousin's name.

THINK YOU COULD DO ANYTHING UP HERE!

Mrs. YANCY recalled that in conversation with Mrs. QUIN, on one occasion, Mrs. QUIN remarked that her son, MARTIN, was a secretary in Germany for ADOLF HITLER and she, Mrs. QUIN, had asked him to come to the United States to visit her but he could not since HITLER would not allow him to do so.

Mrs. YANCY stated that she did not recall whether Mrs. QUIN stated that her son's name was MARTIN BORMANN, but, after reading the article in the Reader's Digest, she thought the above information may be pertinent.

She could furnish no further information regarding this matter.
