1. PBSWING OFFICER JUST BACK FROM LEAVE REPORTS MAN ANSWERING
GENERAL DESCRIPTION MAN CITED WAS TALKING WITH AMERICAN
TOURISTS AT HOTEL EGMONT RESTAURANT COPE EVENING OF 16 JULY AND
POSING AS KUBARK OFFICER STATIONED NURNBERG GIVING NAME AS "WILLIAM
BAKER". WOULD APPEAR BE UNBALANCED INDIVIDUAL BENT ON CHARACTERIZING
SELF AS KUBARK. SALUTES AND NORW IMMIGRATION AUTHORITIES HAD NO
RECORD GUNKER REDEL ALTHOUGH FOUND THAT ONE ERNA HINSCH LIVES AT
SUMMSGATE 200 OSLO AND NOT SUNDESGATE (AS GIVEN BY REDEL).

REDEL, GERMAN OF POLISH ORIGIN RESIDING HAMBURG ON HOLIDAY
OSLO, APPROACHED PBSWING 13 JULY. SAID WAS KUBARK EMPLOYEE AND WISHED

SEE INTEL OFFICER, ALLEGEDLY HAD INFO MARTIN BORMANN WHEREABOUTS.
TRACES ON REDEL FROM ADDRESSEES WERE NEGATIVE.
