On July 28, 1965, HAROLD GROTH, Supervisory Investigator, U.S. Immigration and Naturalization Service (INS), Milwaukee, Wisconsin, advised that his office received a communication, dated July 15, 1965, from the Officer in Charge, INS, Frankfurt, Germany, concerning JULIUSZ GRZADZIEL, INS file A7-939-193, who, according to Mrs. RAY LIS, Krakow, Wisconsin, resembled MARTIN BORMANN, Nazi War Criminal.

INS, Frankfurt, Germany, reported that they had been unable, at this time, to review records of MARTIN BORMANN. INS reported that Records of the International Tracing Service, International Red Cross, Arolsen, Germany, checked on July 14, 1965, showed no record of GRZADZIEL as an inmate of various concentration camps. INS noted, however, this could be due to other spelling of his name at the time of registration.

A record was found showing the first knowledge of GRZADZIEL as July 3, 1945, at Bremerhaven, Germany. He was registered as from the Cham, Bavaria Camp with Assembly No. 187. His date of birth checked with that of JULIUSZ GRZADZIEL, and his place of birth was shown as Kroiev-uta, Poland. His parent's names were identical with those given by JULIUSZ GRZADZIEL. At the time of his registration, he gave his past occupation as clerk of a bank and journalist. These records indicate he was resettled in the United States on December 6, 1950. The records show that he was in Vienna, Austria, in December, 1961, at which time he filed a claim for indemnity with the German Government. He showed his address as care of K. F. RYAN, Vienna 20, S. Messbach 67. The signature on the claim was identical with that of JULIUSZ GRZADZIEL, INS file A7-939-193.
