1. WE HAVE REQUESTED, THROUGH [redacted] WHO WILL USE AN INTERNATIONAL DETECTIVE AGENCY OR CREDIT REPORT INSTITUTION/ A CHECK ON THE CURRENT STATUS OF AECAMBARO/2'S DIVORCED WIFE AND THE DAUGHTER. IT WILL TAKE US ABOUT THREE WEEKS TO GET AN ANSWER.

2. ALL PARTIES CORRESPONDING ON THIS MATTER SEEM TO BE IN AGREEMENT THAT AECAMBARO/2'S DIVORCED WIFE INITIALLY SHOULD BE CONTACTED BY A LETTER FROM A LOCAL [redacted] WE REQUEST OPERATIONAL APPROVAL TO USE [redacted] IN THIS ROLE. HIS STATIONERY, WHICH INDICATES THAT HE IS A RETIRED APPELLATE COURT JUDGE, WILL SUPPORT THE LEGITIMACY OF THE AUTHOR. A CHECK ON HIM WILL INDICATE THAT HE IS A NORWEGIAN CITIZEN, WHICH SHOULD ALSO NOT HURT IN THIS SITUATION.

3. WE DO NOT ASSUME, AS DOES PARAGRAPH 2 OF REFERENCE A, THAT HEADQUARTERS INTENDS WE WRAP UP THIS MATTER BY OBTAINING A QUIT CLAIM FROM THE FORMER WIFE. IN SIMILAR CASES WE HAVE HANDLED, WE HAVE AGREED THAT THE MONEY IS AVAILABLE UNDER CERTAIN CONDITIONS AND AFTER THE ARRANGEMENTS WERE CONCLUDED THE MONEY WAS MADE AVAILABLE WITHOUT FURTHER ADO. WE WOULD PROPOSE IN THIS CASE THAT AFTER THE ARRANGEMENTS ARE CONCLUDED, ANY FUTURE INQUIRIES BY THE GUARDIAN OF THE HEIR TO AN OFFICIAL ODYOKE DEPARTMENT RECEIVE A "NO KNOWLEDGE" ANSWER. [redacted] WOULD BE INSTRUCTED TO SAY THAT HE DOES NOT KNOW THE PRESENT WHEREABOUTS OF THE CLIENT. WE ARE PERSONALLY NOT IMPRESSED WITH THE EFFICACY OF QUIT CLAIMS IN DEALS LIKE THIS. OUR EXPERIENCE IS THAT WE WILL EITHER HEAR MORE FROM THE INDIVIDUAL OR WE WON'T, WITH OR WITHOUT A QUIT CLAIM, AND PROSPECTIVE CLAIMS BY THE SAME PARTIES WILL OR WILL NOT BE ACCOMMODATED OUTSIDE OF LEGAL FORUMS. HEADQUARTERS' REQUIREMENTS ON THIS POINT ARE REQUESTED.

4. INASMUCH AS THE MONEY PAYABLE IS LEGALLY AND MORALLY THE PROPERTY OF THE MINOR CHILD, AND THE FORMER WIFE IS MERELY THE TRUSTEE FOR THE CHILD, WHAT, IF ANY, TRUST RESTRICTIONS DOES HEADQUARTERS DESIRE THAT WE IMPOSE. WE CAN, IF DESIRED, MAKE ARRANGEMENTS THROUGH [redacted] AND A SWISS BANK /OR OTHERWISE/ TO PROVIDE THAT ONLY A LIMITED AMOUNT WOULD BE PAID FOR THE CHILD'S SUPPORT UNTIL SUCH TIME AS SHE REACHES MAJORITY.

WE SUGGEST SINCE THIRTY-FIVE THOUSAND DOLLARS OR FIFTY-TWO THOUSAND DOLLARS IS AN AMOUNT OF MONEY WHICH FEW PEOPLE LIKE TO CARRY AROUND IN CASH, AND WHICH MIGHT ATTRACT SOME ATTENTION IF FUNDED TO A PRIVATE ACCOUNT THROUGH A BANKING SYSTEM IN ONE TRANSFER, THAT WE HAVE *E 7* AT THIS TIME OPEN A NUMBERED ACCOUNT IN SWITZERLAND. OVER A PERIOD OF SEVERAL MONTHS A SERIES OF TRANSFERS COULD BUILD UP A MINIMUM OF THIRTY-FIVE THOUSAND DOLLARS TRANSFERRED TO THIS ACCOUNT THROUGH AN INTERMEDIATE SWISS BANK ACCOUNT /USED TO CUT OUT THE PRIME SOURCE/. WE CAN OBTAIN A POWER OF ATTORNEY ON THE NUMBERED ACCOUNT FROM *E 7* AND BY THE TIME THE MONEY IS TO BE PAID, OR TRANSFERRED TO ANOTHER SWISS BANK ACCOUNT, IT WILL BE AVAILABLE WITHOUT HAVING ATTRACTED TRANSFER OR DEPOSIT ATTENTION.
