AS SOON AS THE TRACE RESULTS SOLICITED IN REFERENCE B ARE IN, WE ARE READY TO PROCEED WITH WRITING A LETTER TO AECAMBARO/2'S WIFE THROUGH [ ] [ ] ALONG THE LINES WE HAVE DISCUSSED IN EARLIER CORRESPONDENCE. IN THE MEANTIME, A FEW POINTS WARRANT CLARIFICATION.</p> <p>2. REFERENCE A CITES SEVERAL COMMUNICATIONS WHICH CONTAIN REFERENCE TO AN INDIVIDUAL WHO MAY BE AECAMBARO/2'S DIVORCED WIFE'S LATEST HUSBAND. AS WE STATED IN REFERENCE B, GERMAN STATION COPIES OF ALL OF THESE DOCUMENTS HAVE BEEN DESTROYED OR RETIRED. IS THERE ANY INFORMATION IN THESE DOCUMENTS WHICH WARRANTS CONSIDERATION ON OUR PART BEFORE WE INITIATE OUR CORRESPONDENCE AND MEETINGS WITH THE DIVORCED WIFE.</p> <p>3. IN REVIEWING THE LOCAL SCANTY FILES ON AECAMBARO/2, IT HAS COME TO OUR ATTENTION THAT EGFW-5505, DATED 2 OCTOBER 1957, STATES THAT "...IN SO DOING, WE FOUND HIS LAST WILL AND TESTAMENT...." EGOW 1468, DATED 7 APRIL 1960, STATES "...SINCE THE DECEASED AGENT LEFT NO WILL..." THIS CONFLICT SHOULD BE LOOKED INTO. IF IT AFFECTS OUR PLANS, PLEASE ADVISE US.</p> <p>4. EGOW 1468 STATES THAT 52,000 DOLLARS IS PAYABLE TO AECAMBARO/2'S BENEFICIARY. EGOW 1543 STATES THAT BEFORE COMMITTING OURSELVES TO 52,000 DOLLARS WE SHOULD ASCERTAIN IF THE DIVORCED WIFE HAS ANY INFORMATION WE DO NOT HAVE ON WHETHER AECAMBARO/2 IS DEAD. WE WOULD LIKE SOME GROUND RULES ON JUST WHAT WE CAN SAY--35,000 DOLLARS OR 52,000 DOLLARS. IT IS OUR THINKING THAT WE SHOULD NOT GO INTO DETAILS ON THE FIGURE WE OFFER IN TERMS OF AN EXPLANATORY BREAKDOWN OF SO MUCH COMMERCIAL INSURANCE POLICY, SO MUCH CONTRACTUAL DEATH BENEFIT, SO MUCH ACCRUED SALARY. TO DO SO LEADS ONLY, IN OUR EXPERIENCE, TO DEBATING DETAILS WHICH WE WOULD DO WELL TO AVOID.</p> <p>5. WE WOULD LIKE, DURING THE OPENING GENERALITIES DISCUSSION, TO DETERMINE WHETHER THE DIVORCED WIFE KNOWS ANYTHING ABOUT AECAMBARO/2'S FATE SUBSEQUENT TO OUR LATEST INFORMATION. IF SHE DOES WHICH IS UNLIKELY, AND HER INFORMATION INDICATES THAT HE MAY STILL BE ALIVE, WHAT ARE WE THEN TO SAY THE "GRATUITY" FIGURE IS TO BE. IF SHE KNOWS NO MORE THAN WE DO, MAY WE AT THAT TIME STATE THAT THE LOCAL EQUIVALENT FIGURE OF 52,000 DOLLARS IS TO BE MADE AVAILABLE TO AECAMBARO/2'S DAUGHTER /UNDER TERMS AND CONDITIONS WE WILL STIPULATE/</p> <p>6. WE SUGGESTED IN EGOA 10109 THAT THE FUNDS NECESSARY TO MAKE THIS PAYMENT OR TO ESTABLISH THE TRUST ACCOUNT, BE FUNDED IN INSTALLMENTS UNLIKELY TO ATTRACT ATTENTION TO AN ANDERKONT O SET UP IN SWITZERLAND BY [ ] [ ]. WE HAVE RECEIVED NO REACTION TO THIS SUGGESTION. WE WOULD APPRECIATE YOUR THINKING ON THIS MATTER AND SPECIFICALLY WHAT WE CAN SAY IN DISCUSSIONS WITH THE DIVORCED WIFE AS TO THE TIME FACTOR THAT WILL BE INVOLVED IN CONCLUDING THE ARRANGEMENTS. THE QUESTION IS - WHAT WORD WILL YOU AWAIT BEFORE MAKING THE MONEY AVAILABLE AND DO YOU AGREE THAT IT SHOULD BE FUNDED IN INSTALLMENTS TO A TRUST ACCOUNT SET UP IN [ ] [ ]'S NAME IN SWITZERLAND.</p>
