2. DOCUMENTS IN OUR POSSESSION NOW GIVE US COMPLETE CONTROL

OVER SWISS BANK ACCT. WIDOW AND BENEFICIARY HAVE NO ACCESS TO

FUNDS EXCEPT FOR THOSE TRANSFERRED ANNUALLY FROM SWISS BANK ON

3. ARRANGEMENTS FOR SWISS BANK ACCT PROVIDED FOR GENEROUS INTEREST PAYMENTS BASED ON DEPOSIT OF ABOUT \$50,000 IF LEFT ON DEPOSIT FOR 5 YRS. MAKING DEPOSITS IN INSTALLMENTS PER REF B WILL DELAY BEGINNING OF INTEREST PAYMENTS AND COULD RESULT IN LOWER RATE OR NO INTEREST.
4. BIO DATA PROVIDED REF C. WILL VISIT WIDOW AND ATTEMPT TO OBTAIN ADDITIONAL INFORMATION IF YOU WILL ADVISE EXACTLY WHAT YOU WANT. HOWEVER, DEPOSIT OF FUNDS AND FIRST PAYMENT TO BENEFICIARY SHOULD NOT DEPEND ON THIS MEETING.
