2. Agent reported **SECURITY INFORMATION**

a. that he had not been able to go to Berlin because no inter-zone pass had been provided.

b. that he had made a trip through the Northern section and had visited 2 or 3 agents in order to find out how many agents would be able to go to school. He reports at this point that only HALPICK will be able to attend school in October.

c. concerning spotting, agent turned in 10 names of people whom he proposed for radio operators. Case Officer inspected these and turned back 8 for lack of definite information, and kept 2 which should be processed soon.

d. Agent's accounting was handed over, inspected by Case Officer and accepted.

Agent, however, states that he would prefer to be put on a Per Diem basis so that he will not have to "collect" so many receipts. Agent and Case Officer decided that 30 IM per day while Agent was "on the road" would be a fair amount.

e. Agent reported that the fighting group organization was progressing but needed some money to complete certain arrangements in this organization. However, Case Officer stated definitely that no money would be advanced for any fighting group.

f. Agent reported that the official vehicle had been painted green as per instructions.

3. Case Officer instructed Agent:

a. to go to Berlin this month and establish as many contacts as possible because the East Zone Iron Curtain was quickly becoming an actuality.

b. that Agent was to continue his spotting as per instructions given at the 1st of July.

c. Agent was instructed to obtain more details when he spotted a person so that we would not have to waste time in 2 or 3 meetings.

d. Agent was instructed to "clean up" the left over balance in his accounting by the next accounting period.
