1. In accordance with the decisions made by [ ] and [ ] and those outlined in references "a" and "b", concerning the termination of certain agents of TPAPLUCK, the following steps have been taken:

- a. JB-33 has been terminated and a quit-claim signed by him. All contact between [ ] and JB-33 has been broken off with no further contact planned. A copy of the final contact report is attached along with a copy of the quit-claim for the Security Section.
- b. JB-35 has also been terminated and a quit-claim signed by him. [ ] had scheduled a contact for 5 January 1953 with him for the purpose of seeing how things were going with him. JB-35 failed to show at the regular or alternate time. In view of the fact that the contact was for social reasons and the last one, as all financial matters had been cleared up, no attempt is contemplated to remake contact with the agent. The past dissatisfaction of JB-35 (Ref. "c") is now straightened out and he should not become a problem. All bogus papers had been previously picked up. A copy of the final contact report is attached along with one copy of the quit-claim for the Security Section.
- c. Because [ ] sees JB-47 so infrequently, he has not been able to terminate her as yet. She is to be contacted within the next week at which time [ ] plans to terminate her. This should come as no shock to her as past contacts have given an air of uncertainty to her future with us. A final settlement of two months salary is contemplated. If all goes well at the next contact, no future contact is contemplated.
- d. The termination of RNMOSKI has been accomplished with the signing of a quit-claim. On [ ] instructions, [ ] plans to keep in contact with him. The next contact is planned in February. At that time [ ] plans to discuss with him more of his future plans. Copies of the final contact report are

2. At the time it was decided to drop RIMOSEKI, it was also decided that if he did not wish to leave the country, then the rest of the [ ] IWT net would also be dropped. JB-33, JB-35, and JB-47 represent the only members of the net who had received any instruction from us. Their disposition is discussed above in paragraph "1". The following are also to be dropped:

These agents have had no contact with staff personnel nor have they received any training. Their disposal presents no great problem.

3. It is also desired to drop JB-5 at this time because of his past connections with the B.D.J. and because his name had originally been submitted by Hollocks. He had never been recruited nor in contact with staff personnel. Through an oversight this had not been officially done before as had been planned some months ago.

4. The disposal of JB-2, a former instructor, has progressed to the point that he knows that after February he will be no longer paid by us. His wife, who acted as a housekeeper, is no longer being paid and may be considered dropped. JB-2 represents, as an ex-instructor, a potential staybehind agent. He has received all the necessary training and it would be only a question of a final briefing and equipping him. The security problem arising out of JB-2's knowing other agents whom he had instructed, is considerably diminished because all of those agents are being dropped. JB-2 knew them under an assumed name and because of his security consciousness, it is safe to assume he protected his true identity. Approval is requested to give him a final briefing and equip him.
