OPERATIONAL

KEMOSKY - Contact Report

1. On 2 April 1953 [] met KEMOSKY in Stuttgart.

2. KEMOSKY reported that he decided to go to work for Dr. Graf of Horn/Lippe (See HQ-4-12546 for a name trace on Dr. Heins-Joachim Graf). He said that his work for the first three months would be to learn everything he could about the Finnish shipping industry with special emphasis on those Finnish ships which visited Satellite and Soviet ports on the Baltic. During this period he expects to make whatever contacts he can from among his old colleagues. At the end of this time he will move to Hamburg to take up his residence and develop the operation. Dr. Graf did not definitely tell him what the operation would be at the end of three months but he felt it would be for intelligence purposes. For his cover, KEMOSKY has become a salesman for a leather firm in Stuttgart and a motorcycle firm in Bielefeld. [] asked KEMOSKY what had happened to his offer of a job from Utility. KEMOSKY was especially vague in his answer of how it fell through.

3. Concerning his employer, Dr. Graf, KEMOSKY was not sure exactly for whom he worked, but was convinced that it was the British. KEMOSKY believed that Dr. Graf was setting up, with the help of the British, a group of experts on foreign countries similar to the group that Utility has set up. KEMOSKY had no way of confirming this but he felt it to be a logical assumption with all of Dr. Graf's activities and contacts in the British Zone.

4. KEMOSKY told [] that he could always be contacted

5. [] and KEMOSKY had a short discussion on the changes in the current Russian line which was of no significance. KEMOSKY also discussed his current shortage of cash and apparent need for money. He did not ask for any money nor did [] give him any.
