1. HAVE FOUND STATE NO LONGER SPONSORS STUDENT EXCHANGES AND ONLY PERTINENT POSSIBILITY KNOWN HERE IS NON DENOMINATIONAL AMERICAN FIELD SERVICE TO WHICH CANDIDATE MUST MAKE APPLICATION DIRECTLY. CURRENT AFS DEADLINE FOR 56 STUDIES IS 1 DEC 55. HAVE ASKED BONN GET CULTURAL ATTACHE VIEWS ON LIKELIHOOD ACCEPTANCE CANDIDATE OF SUBJECT SON BACKGROUND AND ATTAINMENTS, OR GET CULTURAL ATT CHECK OUT WITH AFS PEOPLE WITHOUT NAMES. ONE PROVISION IS THAT CANDIDATE BEAR COST ROUND TRIP SEA TRANSPORTATION. SINCE FAIRLY CERTAIN CARPETMAKER CANNOT COME UP WITH FUNDS FOR THIS HAVE ASKED [] HAVE HIM SUBMIT APPLICATION ANYWAY, INDICATING HE WILL BEAR THESE COSTS AND TELLING HIM WE LOOKING AROUND FOR OTHER SPONSOR.
