Reference reported that Dr. Brueckner's daughter Christiana, age 16, was accepted by the American Field Service for a year's attendance at a high school in the U.S. She departed from Rotterdam on 11 August on the Seven Seas with a group of other students. From N.Y. she will proceed to Atlanta, Ga. where she will live with Mr. and Mrs. Howard V. REED 825 Moore Hill Road, N.W., Atlanta 5. Dr. Brueckner mentioned that Christiana will try to get in touch with <input type="checkbox"/> either on her way to Atlanta or at some later date.</p> <p>2. The middle of July, after Christiana had heard from the AFS that they had not as yet been successful in finding a U.S. home for her, Dr. Brueckner approached us and asked if we could intercede with the proper authorities on her behalf. We checked with the local USIS people but were told that AFS is a privately sponsored organization and the Embassy, while ready to offer advice, is most reluctant about interfering in their affairs. Before we had a chance to ask Hqs if they could contact the the AFS Hqs in N.Y., Dr. Brueckner called to let us know that Christiana had now been assigned a home in Atlanta. Dr. Brueckner is of the opinion that it was a good word from us in the right places which brought the quick action, although this is not the case. We did assist Christiana with her visa formalities.</p>
