1. XI-10064 contains an ODOPAL interrogation report dated 15 September 1945 on Friedrich Heinrich BUSCH, born 3 June 1905 in Berlin, the assistant Gestapo chief of Innsbruck. This is probably the report referred to in paragraph 2 of FRAN 6924 of 15 July 1953. Possibly FOB can obtain a copy of this report from COM. Following are other traces on BUSCH's wartime activities.

Carded information
SS Hstuf. Krim. Kom. BUSCH, born about 1905; 1.71m tall; black hair; round face; full chin; wears horn rimmed glasses; bank clerk by profession; married in Trier; Nazi; took part in the early violence in Berlin; worked in Abt. IV 1, 2 and 4 of Trier Gestapo in 1938-39; may have been in Innsbruck in 1941 and France in 1942.

Carded information
SS Ustuf. Friedrich BUSCH was at Stapoestelle Trier, SD Unterabsehnitt in 1934; Party number 709972, SS Number 280402.

Carded information
Krim. Rat Friedrich Heinrich BUSCH - deputy head of Stapoestelle Innsbruck; born about 1905; former SS Hstuf., but was demoted; formerly served with the Gestapo in France.

2. We would find nothing definite on BUSCH'S postwar activities. We presume he is not identical with the "Frits BUSCH" of MGIA-5232.

Additionally it is planned to conduct an investigation of @ LUEDERS' original field case officer, V-2982 in order to learn whether or not this individual might or might not be have in some way become involved in any duplicity which @ LUEDERS is practicing. At such time as this investigation has had time to warrant definite conclusions, @ KUTZBACH proposes, provided that he can get the necessary approval from his own higher hqs personalities, to run an LOFLUTTER on @ LUEDERS. If necessary @ KUTZBACH hopes to include V 2982 in the operation at the same time. It is felt at this time that nothing can be lost by delaying this situation for approximately another month, at least beyond the next appointed meeting for 26 March in order to see if the RIS proposes to give @ LUEDERS any answer on his request for add. financial support.
