1. CABATON 37 was met recently and provided the following additional information which may be passed to the BfV:

(a) The full name of Subject's daughter is

Jutta \*RESCHKE  
 born ca. 1941.

She is a very clever girl and definitely pro-SED in her opinions. Whenever source is visiting the Pension and if the conversation turns to politics, Jutta praises the DDR and derides the system in the Federal Republic. She seems to be well versed in the political vernacular of the SED and knows all the latest slogans and popular sayings current in the SED. The name of Guenther KROEBER entered the conversation and Jutta mentioned that KROEBER was having difficulty obtaining a permit to leave the DDR. Subject cut in to say that recently another man had come from Leipzig and reported that KROEBER would have to produce two people to vouch for him before he could obtain a travel permit. At that point the daughter interrupted to say that this other man from Leipzig (not further identified) had not really stayed with them but that they had merely heard about him. They obviously do not wish to reveal that they are having such visits. Source estimates that often as many as half of the visitors at subject Pension are from the DDR. There is a private parking lot next to the Pension where cars can be parked without being visible from the street. Source has often seen cars parked there with DDR license plates.

(b) Frau SCHOELL, aka SCHOPFNER, aka KULICKE, aka TUERP: About six months ago source met the cleaning woman at the Pension who was identified to him as Frau SCHOELL. On a second visit she was introduced as Frau SCHOPFNER. In November she was introduced to source's wife as Frau KULICKE. When source telephoned the Pension recently, the cleaning woman answered the phone and identified herself as Frau TUERP. This person comes from Dusseldorf where a married daughter resides. She is described as being about 42-45 years old, about 1.70 meters tall, full figure with heavy bosom. She was brought to the Federal Republic by Subject. Despite a visible improvement in her appearance after having left the DDR, SCHOELL claimed she lived just as well in the DDR as she does here, and only after she had gotten her recognition and her apartment would she consider discussing the matter of improvement in her situation. Apparently her claim is being processed in Dusseldorf. Jutta RESCHKE claimed that if the case were being handled in Frankfurt the matter would have already been settled. In Frankfurt they have a good connection in the person of Frau Dr. Steinsch who is a local real estate broker. This person is undoubtedly identical with

Frau Dr. Irma \*STEINSCH  
 Frankfurt/Main, Feldberg Strasse 9.

(c) With regard to further identification of Guenther KROEBER, source is not in a position to determine if KROEBER is identical with the person described in reference. Source has not personally met KROEBER but he is trying to obtain his address from Subject. As soon as source can obtain further identifying information on KROEBER, we will forward it immediately to Bonn for passing to the BfV.
