1. **SUMMARY:** During this reporting period we have added one new accommodation address and have dropped two, giving us a total of 34 addresses, of which 32 are active. In addition, we have CABATONS-52 and 56 who are not being used operationally pending resolution of their status. Seventeen of our active addresses are assigned for the exclusive use of Berlin.

The mother was allowed to depart from the DDR in November. CABATON-1a continues to perform satisfactorily.

Comments: During August 1960, at the time of ZEDANCE, this address was given by AELICTOR-1 to a Soviet under circumstances which make it appear very likely that this address has been compromised to the RIS. We have recently begun testing this address anew in an attempt to determine the extent of the compromise.

Comments: Subject performs well but needs additional assignments.

Comments: Agent continues to perform satisfactorily. On 2 December 1960 the drop was offered for the exclusive use of Berlin. We have not yet been notified of any specific assignments.

Comments: Agent continues to perform satisfactorily. On 21 December 1960 this drop was offered for use by Vienna for the backtopping of several outside case officers. Thus far no specific assignments have been received.

Comments: Agent has performed well on all tasks given him. He has been assigned exclusively to Berlin.

Comments: The test letter of 4 August, mentioned in the last progress report, was never received. A test letter mailed on 10 November from Berlin and one mailed from West Germany on 12 December were both received by the agent. The test letter of 10 November was mailed from East Berlin by CALERIA-29 who is involved in the CALERIA compromise (ERIN 1913). CABATON-20 is therefore presumed compromised. Contact will be maintained with this agent at least until BOB regains contact with CASHARK-3.

Comments: Since the last progress report CABATON-21 has received and forwarded two operational letters in satisfactory fashion.

Comments: CABATON-23 has moved out of the Jugendwohnheim and has taken a room in a private home. He plans to remain at his present location until February 1961, at which time he will move to Berlin for a semester at the Free University; following that he plans three months study in England. Because of the anticipated delays involved in forwarding mail along this involved itinerary, we will transfer the [] assignment to another CABATON sometime in January.

Comments: CABATON-25 remains as cooperative as ever. Due to his past record with CATBORN his address cannot be used

to high security Bloc mail, but during this period it was made available to two operations, neither of which materialized. He also arranged an introduction to his brother, who is an official in the Land Hessen Arbeitsamt, and who it was hoped would provide useful CATARSI leads. After a lengthy meeting with the brother by a CATARSI case officer, it was decided not to follow up this lead because, as an executive of his organization, this person did not have the access to the files that we had expected.

Contact will be maintained until Berlin is able to warn CASHAG, presumably sometime in January.

Comments: CABATON-56 has been successfully tested a number of times and is anxious to cooperate. However, it has been determined that she suffers from a glandular condition which incapacitates her occasionally. For this reason it has been deemed prudent to continue the testing for several more months before making any operational assignments.

Comments: During this period this agent was assigned a cryptonym, received full OA, and received his first operational assignment.

3. AGENT PROSPECTS: We have at present a small number of prospects and these will be reported on as they are developed. Five of these leads were given us by CABATON-46, one came from CABATON-38, and a number of others have been developed independently by CATARSI case officers. During the coming period we hope to recruit a number of these to replace our recent losses.

4. OTHER MAIL FACILITIES: We now have a total of 21 post office boxes in the Frankfurt area, plus the one in Wiesbaden which is serviced by CABATON-21. We hope to increase this number, although we have no present requirements, in order to have a number of clean boxes on hand. Boxes are serviced on the average of twice weekly, depending upon the requirements of the using operation. We have also been testing the use of the Postlagerkarte, thus far with satisfactory results. Wherever possible, we encourage case officers to use the Postlagerkarte, especially where the situation permits direct servicing by local principal agents. Although the Postlagerkarte involves a personal call at the service window in the post office, no further identification is required and anyone displaying the card can pick up mail.

6. SECURITY: The major security incident affecting this project during the period was the CALERIA compromise in Berlin. At this writing, it appears that the addresses of CABATONS 30 and 42 have been compromised, and it may develop that additional CABATONS are also involved. We are awaiting final word from BOB on this score.

6. FINANCES: During this period our payroll increased DM 25 per month, representing an increase given to CABATON-47. The total amount expended during the reporting period was [] The major portion of the increase over last period represents Christmas bonuses and gifts given agents.

7. DEVELOPMENT AND PLANNING: This paragraph will be covered in the Project Renewal, which is being prepared concurrently.
