1. IN LINE OUR EFFORTS TO HAVE HENARD TAKE BACK SEAT AND IN VIEW HIS OWN WISHES TO BE LESS CONSPICIOUS DURING NEXT FEW MONTHS FOLLOWING STEP WAS TAKEN: HENARD IN LETTERS ADDRESSED TO STATE SECRETARY MINISTRY ALL GERMAN AFFAIRS FRANZ THEDIECK, MINISTER OF JUSTICE THOMAS DEHLER, BFV DIRECTOR, OTTO JOHN, FEDERAL GOVT REPRESENTATIVE BERLIN HEINRICH VOCKEL, MAYOR OF BERLIN ERNST REUTER AND BERLIN SENATOR FOR JUSTICE VALENTINE KIELINGER OFFICIALLY DESIGNATED PAUL M. LADELL DIRECTOR TPEMBER BERLIN WHO PREVIOUSLY WAS ACTING IN THIS CAPACITY DURING HENARD'S FREQUENT ABSENCES FROM BERLIN. DIRECTOR TPEMBER BONN REMAINS UNCHANGED.

2. THE MOST CAREFULLY PHRASED LETTER ESTABLISHES LADELL AS A KEY TPEMBER FIGURE WITHOUT DEPRECIATING IN ANY WAY HENARD'S KNOWN LEADING INFLUENCE IN FACT LETTER COPY OF WHICH BEING POUCHED IS OPEN TO 2 INTERPRETATIONS A. HENARD IS MANAGING ALL 3 TPEMBER
