b. Security Factors

1) Upon advice from HARVARD, the Chief of Mission has replied as follows to recommendations by the Chief of Berlin Operations Base relative to CATIPPET:

- a) CATIPPET's damage claims for settlement on his furniture seem to be double claims.
- b) CATIPPET's termination with HARVARD was a generous one.
- c) CATIPPET's disgruntlement seems to stem not from hardship as such but basically from failure to obtain the specific employment which he desires and from envy of former CADROWN colleagues.

2) In view of the above facts, the Chief of Mission has recommended that initiative for recontact with HARVARD be left to CATIPPET and that scrutiny of his mail continue in order to assess further his plans and prevent incipient damaging action by him.

3) The crucial factors in CATIPPET's case are the circumstances of his termination by HARVARD and the personality assessment of him, as contained in recommendations by the Chief of Mission, Frankfurt. It is difficult to evaluate these factors from here, in a case of this type. Headquarters has therefore rescinded its former concurrence in proposals by the Chief of Berlin Operations Base and has deferred to recommendations made by the Chief of Mission, Frankfurt.
