1. QUESTIONED BY AND WITHOUT FIRST PREVIOUSLY DIVULGING NATURE OF INCIDENT, AND LATER AFTER READ REF CABLE, FOLLOWING INFO OBTAINED KEYED TO REF CABLE.

2. A. KNOWS CARBOHYDRATE DEBRIEFED FULLY BY BRITISH AND FRENCH AFTER DEFECTION, KUBARK ROLE NOT REVEALED. DOES NOT RECALL THAT C MENTIONED ANY FRENCH NAME AND DOES NOT RECOGNIZE GALINET. ONLY FRENCH NAME RECALLS KNOWING IS THAT OF FNU HENNIG MENTIONED IN BOB CAIRN MEMO 95 OF 27 JULY 1953. HENNIG WAS FIS LIAISON MAN TO CADROIT. FURTHER RECALLS THAT FIS ONCE REINTERROGATED C BUT THINKS IT WAS DONE SEVERAL DAYS AFTER INITIAL DEBRIEFING.

B. RECALLS THAT SOME MONTHS LATER AFTER C WORKING IN CADROIT HE SAID SOME OUTSIDE AGENCY PHONED HIS OFFICE AND ASKED HIM ABOUT SOME PERSONALITY IN EAST BERLIN POLICE. OUTSIDE AGENCY MIGHT HAVE BEEN BRITISH, FRENCH, OR US PUBLIC SAFETY. DOES NOT RECALL FRENCHMAN NAMED ELIEM.

DOES NOT RECALL ANY THIRD MESSAGE BUT HAD PHONE

D. [] RECALLS (FRAU) VOELLBORN STAYED ONLY TWO OR THREE DAYS WITH C, WHO ALWAYS PROFESSED NOT TO BE SURE IF HER HUSBAND HAD BEEN FRENCH AGENT. C AND [] OFTEN EXPRESSED BELIEF VOELLBORN HAD BEEN FRENCH AGENT. C ONCE DENIED KNOWING THAT FRAU VOELLBORN GOT MONEY FROM ANY SOURCE BUT HER MOTHER AND UNEMPLOYMENT INSURANCE.

3. PLS CABLE LGFLUTTER RESULTS. INCLUDE QUESTION ON WHETHER C ALSO GOT FRENCH MONEY. PLS TAKE NO ACTION AGAINST C UNTIL FRAN AND WASH CONSULTED.
