CADROIT/CARBOHYDRATE

Date, Time, and Place of Meeting: 26 Oct 54, 1900-2130, C's Apt.

Present: a. CARBOHYDRATE b. []

1. CARBOHYDRATE delivered:

a. Copy of request for cost estimate requested from Freulich for repairing fence around L. 5, fire extinguishers, sundry similar articles.

b. Reproductions of 3 directives of East Berlin police concerning Ausweise and their use, police responsibilities re Anmeldung, Abmeldung, and related matters (approx 17 pages). The source was MA 100. A short discussion took place re MA 100. He wants to come to the West some time in the future, if he can get a job with the West Berlin police. But a recent letter from [] to Urban resulted in the latter's taking the position that no job could be made available, since there are so many applicants available for the limited No. of positions. (We intercepted a copy of [] letter). 100 is presently under no ~~xxxxxx~~ surveillance, but he has to be very careful, suspects that his supervisor is scrutinizing his actions rather closely. 100 ~~may~~ have to come out some time in the future without regard to whether he can get a job in the West or not. [] noted his understanding from an earlier briefing on the case that 100 had spoken with the W. Berlin police years ago (approx 1951,) and ~~xxxx~~ wanted to come out at that ~~xxxxxx~~ time. The police supposedly had offered him a job in the future, if 100 would stay in ~~xxxx~~ the East for the time being. 100 stayed in the East, but fearing penetration of the West police, preferred to maintain contact with CADROIT. C stated that there had been no earlier offer of a job to his knowledge, and that he (C) was thoroughly familiar with the ~~SECRET~~ case, was handling it himself. Three possibilities exist: (1) turn 100 over to the police (retaining right to get copies of his info for CADROIT-he is the only good CADROIT source of the Fahndungsbuch),

(2) have 100 come out when he is endangered, in the hope that he can then get a job with the W. Berlin police (although there is no guarantee here, of course), and (3) drop contact if it ever appears that 100 is really becoming endangered. No action to be taken by C at the present time.

c. Report taken from ~~xxxxxx~~ MA report who had been told by a friend that ~~xxxx~~ the latter had been present when the authorities had confiscated three broadcasting sets/which had been parachuted into the area near Planitz b. Kyritz. One piece of equipment bore the name "Amni", another the name "Onni". The sub-source had supposedly seen English terminology on the sets ("Out", "On", etc.). [] noted it was improbable that the incident was what it appeared to be, since such an infiltration method was improbable. [] of course could not be sure, since he ~~xxx~~ had not worked with infiltration of W.T.~~XXX~~

d. Report of the arrest of 4 of the 5 "Gorlitz boys" who had on their own initiative brought ^{SSD} files to CADROIT which had been thrown in the streets when the crowds stormed the SSD offices in Gorlitz during the 17 June 53 uprisings. Only one of the arrestees, "Karl Mensel" had been recruited as a MA. Despite his youth, he had appeared rather mature and careful. The offer of another (Riedel) had been refused due to his youth and apparent excess of zeal. The arrest of one of the youths (Riedel) had led to the arrest of ~~xxxxxx~~ "Mensel", Burkert, ^{and} Bauch. The last member of the group (A. Fuenfstueck) had gotten away, reported the matter to CADROIT, and will stay in West Germany. The latter had had a ~~xxxx~~ chance to warn Bauch, Burkert, and Mensel. These three, however, had wanted to ~~xxxxxx~~ consult their parents before they fled - a delay which resulted in arrest in each case. The case shows the dangers of group action (Note that this group had been organized on the Members own initiative during 17 June, and had existed ~~before~~ before the contact with CADROIT for purposes of delivering files.) To be fully reported later.

2. C reported orally that one of the two "Schwarzwächter" (CADROIT employed guards for L. 29) was leaving his job. He had been a ^{partially} disabled Rentner who received unemployment ins. in addition to the 180 DM/Mo. which he received from CADROIT. This situation had been reviewed; it was felt that it could not be continued. But the guard could not live on DM 180/mo. He thus decided to quit the job. C has been interviewing persons in order to secure a new man for this job, and for a number of clerical positions (only one new clerical position is involved, but it requires shifting a number of persons now holding various clerical jobs.) C is thus doing personnel work to some extent, as well as security work (some of the personnel work has a security aspect).

3. [] request name trace on Kirstaedter.

4. C reported that in a discussion between C and Ladell re [] previously laid on requirement that [] hear of any cases of real SSD ^{Abt. ES,} Spitzels before they go to ~~XXXXXXXX~~, Ladell had said clearly that (1) none of these cases would go to CASTANIA, and (2) Ladell would ~~himself~~ himself make the decision as to how these cases would be handled in the future. (To be discussed with Harrison).
