Date, Time, and Place of Meeting: 29 Oct 54, 1700-1930, CARBOHYDRATE's Apt.

1. C delivered:

a. Two reports from refugees re SSD personalities. (For ~~SSA~~ BOB/CART)

b. Report giving further info re the arrest of "Wilhelm Leim", which was reported many months ago. The recent info, which comes from the arrestee's daughter, who fled to West Germany before the arrest, indicates that the arrest had nothing to do with CADROIT activities.

The sentence was three years, and the main charge during the trial ^{apparently} was/the fact that the daughter was in the West.

2. C reported that:

a. Zimmerman ~~divorced~~ divorced his wife approx ^{two to} three months ago (on grounds of unfaithfulness during the war). The son ~~is~~ will remain in West Berlin; the daughter will remain in East Germany with the mother.

b. That when the previously self-announced NTS worker appeared on 27 Oct, that C had advised her ~~that~~ that the "emergency number" had been changed. C had learned the new number. The NTS worker called, was told to come to the appropriate office, and ~~left~~ left CADROIT to do so.

C will remain out of the picture in the future, of course.

c. CADROIT had no trace on K. or W.

3. C delivered a number of completed security check sheets for the various rooms. All are not yet complete. A detailed discussion of various items on the overall form re L 29 was carried out.

4. [] informed C that efforts to simplify the ~~present~~ former method of reimbursing C for his services had been ^{successful} simplified. From now on, C would receive a straight salary of DM 850 per month. DM 700 would come from CADROIT; DM 150 would be paid direct. [] stated it to be a condition that C maintain a ~~xx~~ suitable watchdog (which C does). The net income each month was thus raised by ~~xx~~ DM 25. Also included were provision to review C's work ~~SMITHSONIAN~~

at regular intervals (stated to be roughly one year, perhaps) with the possibility that such reviews might result in readjustments of C's ~~min~~ salary. [] was quite ~~careful~~ careful to avoid in this connection any hint of a commitment to increase C's salary at regular one year intervals. The review was stressed, ~~rather~~ rather than the possibility of a raise as a result of the review. [] then informed C that it had been possible to make the raise retroactive to 1 July. [] thus paid C (a) DM 150 against receipt, as part of his November salary, and (b) DM 150 against receipt as the total retroactive raise due him since 1 July. C seemed to be well satisfied with the arrangement outlined by []. It appeared that the review provision particularly appealed to C, although he did not discuss the matter at any length. It should be noted finally, that [] made it clear that the present "lump sum" salary arrangement was based upon the assumption that C had no car.
