1. C delivered:

a. Copy of report written by Dr. Wolff who had been informed by Abt. V that an arrested SSD Spitzel named Diller had confessed that he had among other EEI'S the job of kidnapping Dr. Wolff. Further details including full name of Spitzel are not yet available. Wolff noted that the SSD Spitzel's story re EEI could be ~~xxxxxxxxxxxx~~ false, and thought that this might be the SSD's way of uncovering the true identity of CADROIT staffers, since a court case in West Berlin would require the staffer to reveal his true identity. (This theory seems improbable)

Wierichs in Abt V is to give C a full report on the matter. Note: [] has reports from LCPAGAN that Abt V has informed latter that a fru Diller, ~~XXXXXXXXXXXX~~ now in West Berlin jail, had confessed to working for SSD, was supposed ~~XXXXXXXXXX~~ to take action against [], and actually did take part in abortive attempt to kidnap an LCPAGAN worker. This appears to be the same Diller.)

b. A report written by Dr. Ehrlich (works with B. and Bu. Karbi) re an old friend of his out of the East zone who had been spitzelverpflichtet and set on Ehrlich. The Spitzel, Alfred Lengner, appeared at Ehrlich's apt purportedly by accident, and spent a number of hours there talking to Ehrlich. The latter became suspicious of Lengner for a number of reasons, and telephoned C after Lengner had left for the night. It was decided to have Abt V pick the man up right away, which was done. Lengner has confessed/working for the SSD, but denied knowing anything about a man who appeared to be standing on the corner near Ehrlich's apt during Lengner's visit, and whom Lengner appeared to watch from the window from time to time. 3. A collection of miscellaneous reports on the SFS. All came from visitor's reports except one, which carried no indication of the source.

C stated in response to query that the information had come ~~far~~ from Ledell. C did not know who the original source was. Did have any MA who represented penetrations of considerable value into the SFS.

C replied in the negative, so far as he ~~knows~~ knew. All reports to go to BOB/CART as usual.

4. Report re a refugee mother whose two daughters, Herta and Gisela Schoen, who used to work in a Western Intel.-connected group headed by a Herta Osterwit,, 30 yrs. old, in Luckenwalde, had been arrested on 12 Oct 54. The visitor's son had also been temporarily arrested on 23 Oct. The daughters used to live directly opposite a Russian barracks. They used to come to West Berlin for agent meetings in Zehlendorf, Goethestr. Neither the visitor nor C expect an answer, but C put this in for general interest.

2. requested a check of Frau Winkler, Kudams 136, for Bob E.

3. requested a check of E. Woden for BOB/CART.
