3 March 55

Date, Time, and Place of Meeting: 2 March 55, 2000-2130, CARBOHYDRATE's Apt.

Present: a. b. CARBOHYDRATE

1. The purpose of this meeting was to brief CARBOHYDRATE on his trip to Frankfurt to discuss the CACARANA 2 divorce case with the latter's lawyer (Dr.

Napp) and possibly with CACARANA 2 herself. Since the ~~subject~~ possibility of such a trip had already been covered in general terms earlier, this meeting served to firm up matters started earlier. It was agreed that:

a. CARBO would leave by courier either 3 March PM or 4 March AM. to inform finally before 1200 3 March.

b. CARBO will receive 25 DM/day "per diem" during his stay in Fran ~~Frankfurt~~ already checked out with .

c. CARBO will speak with Napp first. It is our best estimate that Napp knows only what CACARANA 2 has told him of the affair, does not realize that she was an accessory to the espionage which she charges against her husband. When Napp understands that, seen strictly as a matter of law, no divorce can be secured on espionage grounds if CARBO testifies, Napp can probably be induced to use all methods to stop the subpoena of CARBO.

d. CARBO will not necessarily speak with CACARANA 2. If this proves necessary, it may be well to point out to her that she can certainly not expect the cooperation of the U.S. in gaining entry to that country unless she drops her efforts to prove CACARANA was guilty of espionage for the U.S. An absolutely guiltless divorce is not necessary on her part. Extra-marital relationships would not necessarily bar entry to the U.S. But charges of espionage will most certainly not get her a divorce. However, it was concluded that it would be better not to speak with CACARANA 2 unless this proves necessary after discussion with Napp.

e. CARBO should under no conditions appear in court in Fran (he laughed at the idea when brought it up, but it is just as well to make sure). In this

connection, the following emergency contact arrangements were made: if CARBO meets with some surprise development, must see [] at once, he is to call his wife saying that he wants to see his friend. The wife has [] unlisted telephone number. [] can fly to Fran and reach CARBO at his temporary address there. This arrangement is only for absolute emergencies, of course.

2. [] noted that ~~minimum~~^{he} desired to have CARBO deal directly with the persons involved in the divorce case only to prevent the upcoming subpoena; as soon as this ~~is~~ is accomplished, CARBO should pull himself out of the picture as much as possible (having in mind that a separate HARVARD line will probably be set up by that time to take care of CARCERANA 2's resettlement, which is not really CARBO's business).

3. CARBO noted that the former ~~Widerstandsgruppe~~ Brandenburg group leader who had been offered a secretarial job with VOPO had been sent to CALCINO per [] instructions. []
